At 6:30 P.M., Mayor Steve Brewer gave the invocation. After the invocation, Mayor Brewer led everyone present in reciting the Pledge of Allegiance to the Flag of the United States of America. He then declared that a quorum of the City Commission was present and called the meeting to order.

REVIEW AND TAKE ACTION TO APPROVE MINUTES OF PROCEEDINGS OF THE REGULAR MEETING OF THE CITY COMMISSION HELD ON TUESDAY, MARCH 9, 2010

After review of the minutes, Commissioner Lori Weaver moved to approve the minutes of proceedings of the regular meeting of the City Commission held on Tuesday, March 9, 2010. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commission.

CONSIDER AND TAKE ACTION TO CANCEL THE MAY 8, 2010 GENERAL ELECTION OF THE CITY OF LA FERIA IN ACCORDANCE WITH SECTION 2.053 (A) OF THE TEXAS ELECTION CODE

City Manager Sunny K. Philip said that only the incumbents filed for a place on the ballot for the May 8, 2010 General Election, and under Election Code, the City's governing body can cancel the election. Commissioner Angelica P. Baldivia moved to cancel the May 8, 2010 General Election of the City of La Feria in accordance with Section 2.053

(A) of the Texas Election Code. Commissioner Lori Weaver seconded the motion, and the motion carried by unanimous vote of the City Commission.

REVIEW BID TABULATION AND CONSIDER AWARD OF CONTRACT ON PURCHASE AND INSTALLATION OF FOUR (4) GENERATORS AT FOUR EXISTING LIFT STATIONS

City Manager Sunny K. Philip explained that there were seven bids received for this project.

Mr. Philip said that Global Electric submitted the lowest bid, but they did not meet all the bid specifications, so his recommendation was to reject the bid submitted by Global Electric and award the bid to Metro Electric, the next lowest bidder in the amount of \$252,375.00. This will be funded through the Disaster Recovery money and local funds. This is the first project in the Valley to be funded through the Disaster Recovery funds. Commissioner Gonzalez, Jr. noted that the City of Mission is just now going out for bids for their Disaster Recovery project. Commissioner Victor Gonzalez, Jr. moved to reject the low bid from Global Electric and to award contract to the next lowest bid Metro Electric from McAllen, Texas in the amount of \$252,375.00 for the purchase and installation of four generators at four existing lift stations. Commissioner Angelica P.

Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commission.

CONSIDER AND TAKE ACTION TO ADOPT PROCLAMATION PROCLAIMING APRIL AS "FAIR HOUSING MONTH."

Commissioner Victor Gonzalez, Jr. asked that the Fair Housing Proclamation by read. City Attorney Miguel D. Wise read the Fair Housing Proclamation. After reading of the proclamation, Commissioner John Betancourt moved to adopt proclamation proclaiming April as "Fair Housing Month." Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commission.

CONSIDER AND TAKE ACTION TO APPROVE OR DENY A RESOLUTION OF THE CITY OF LA FERIA, TEXAS, ENDORSING CERTAIN LEGISLATIVE CHANGES RELATING TO THE SUNSET REVIEW OF THE TEXAS PUBLIC UTILITY COMMISSION AND THE SPECIAL PURPOSE REVIEW OF THE ELECTRIC RELIABILITY COUNCIL OF TEXAS

Commissioner John Betancourt moved to read the resolution by caption only in lieu of reading it in its entirety. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commission. City Attorney Miguel D. Wise read the caption of Resolution 2010-12. After reading of the caption, Commissioner John Hernandez moved to approve Resolution 2010-12 endorsing certain legislative changes relating to the Sunset Review of the Texas Public Utility Commission and the Special Purpose Review of the Electric Reliability Council of Texas. Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commission.
