- 3) Present to the court a certified copy of my driving record from DPS DR 1 Form: <http://www.dps.texas.gov/> (fee may apply)
- 4) Take a driving safety course approved by the Texas Education Agency, or if operating a motorcycle, a motorcycle operator's training approved by the Department of Public Safety, completed by \_\_\_\_\_.
- 5) Present to the court a uniform certificate of driving safety course completion from a Texas Education Agency approved course (or from a DPS approved motorcycle course) by \_\_\_\_\_.
- 6) Upon return of this form, it MUST be accompanied by an administrative fee plus court costs in the amount of \$\_\_\_\_\_ within fifteen (15) days.

I understand that:

- 1) If I complete a driving safety course within 90 days, the charge against me will be dismissed and that the court will report to the Department of Public Safety the completion date of the driving safety course for inclusion on my driving record.
- 2) If I fail to present to this court proof of completion of the driving safety course (original court copy) by \_\_\_\_\_, the court will require my appearance at a show cause hearing;
- 3) If I fail to appear at the show cause hearing, the court will impose the Fine with a Guilty verdict and may issue a warrant for my arrest.
