At 6:30 P.M., Mayor Steve Brewer asked Commissioner Lori Weaver to give the invocation. After the invocation, Mayor Brewer led everyone present in reciting the Pledge of Allegiance to the Flag of the United States of America. He then declared that a quorum of the City Commission was present and called the meeting to order.

After review of the minutes, Commissioner John Betancourt moved to approve the minutes of proceedings of the regular meeting of the City Commission held on Tuesday, February 9, 2010. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commission.

Mr. Jeff Garcia with the law firm of Linebarger Goggan Blair and Sampson LLP was present to review the private bids received on the tax resale conducted in November 2009. Mr. Garcia explained that the amount of taxes owed to the City in judgement value was \$8,134.91 and what the City would get from these bids was \$1,779.47, which was 22 cents on the dollar. Mr. Garcia said that the benefits of approving these bids tonight would be that the properties then go back on the tax rolls and the new owners begin to pay taxes. Mayor Brewer said the City Commission did not approve the bids the last time it was presented, and the City wanted to purchase the properties from the school and the county for housing development. He inquired what had happened to that. City Manager Sunny K. Philip said that at the last presentation, Mr. John Guevara was present and the City Commission rejected the bids with the idea that this would be a good opportunity to begin an affordable housing program. Mr. Philip said he contacted Mr. Guevara, but somehow there was no feedback. Mr. Philip added that La Feria has formed a non-profit group to promote housing and what the City is looking for is to purchase these properties to redevelop the area. Mr. Garcia explained that the City of La Feria would have to be present at the tax resale and have an authorized agent to purchase the property or submit a letter of offer. Then that offer would have to go before all the taxing entities for approval. Commissioner Lori Weaver moved to table this item until after Executive Session. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commission.

### ANNUAL RACIAL PROFILING REPORT PRESENTED BY POLICE CHIEF DONATO GARCIA

Police Chief Donato Garcia reviewed the 2009 Racial Profiling Report with the Commission. There were a total of 1,384 citations and 847 warnings. There were no racial profiling complaints.

Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commission. City Attorney Miguel D. Wise read the caption of Resolution 2010-06. After reading of the caption, Commissioner John Betancourt moved to approve Resolution 2010-06 authorizing the inclusion of weekend voting to be held on Saturday, May 1 and Sunday, May 2, 2010 and designating that the extended hours (12-hour days) be held on Monday, May 3 and Tuesday, May 4, 2010 for the City General Election 2010 and establishing hours for Saturday, May 1 to be from 10:00 A.M. to 2:00 P.M. and Sunday, May 2, from 2:00 P.M. to 6:00 P.M. Commissioner Lori Weaver seconded the motion, and the motion carried by unanimous vote of the City Commission.

Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commission. City Attorney Miguel D. Wise read the caption of Resolution 2010-07. After reading of the caption, Commissioner Lori Weaver moved to approve Resolution 2010-07 of the City Commission of La Feria, Cameron County, Texas, ordering a General Election in the City of La Feria on Saturday, May 8, 2010 for the purpose of electing a Mayor and a City Commissioner for position number one, and a City Commissioner for position number two on the City Commission to hold office for a period of three years, designating polling places, providing for designation of officers for such election, ordering notice of election to be given as prescribed by law in connection with such election, and providing for other

matters relating to the General Election. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commission.

# CONSIDER AND TAKE ACTION TO APPROVE THE FIRST AMENDMENT TO THE FINAL FINANCE AND DEVELOPMENT PLAN CREATING A PROPERTY OWNERS ASSOCIATION FOR TAX INCREMENT REINVESTMENT ZONE NUMBER ONE CITY OF LA FERIA DEVELOPMENT PROGRAM

City Manager Sunny K. Philip explained that the Tax Increment Reinvestment Zone Board met last week and approved an amendment to the Final Finance and Development Plan, which creates a Property Owners Association and the bylaws for the association. The creation of a Property Owners Association will score additional points on funding applications. Commissioner John Betancourt moved to approve the First Amendment to the Final Finance and Development Plan creating a Property Owners Association for Tax Increment Reinvestment Zone Number One City of La Feria development program. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commission.

City Manager Sunny K. Philip reported on the following:

• The Fiesta de La Feria will be held on Saturday, February 27, 2010. The visitor's guide publication contains the Fiesta Day activities in the centerfold of the guide. There are three stages, one on Commercial, one on Primrose, and one in the old theater building where the arts and crafts will be held.

- The Kelly Miller Circus is on March 8, 2010. There will be two performances, one at 6:00 P.M. and one at 8:30 P.M. Tickets are available at City Hall and the Library. This is a fundraiser for the Library.
- There will be a final inspection on March 4, 2010 on the water and wastewater system improvement projects. The completion deadline is March 31, 2010. Staff will be placing a resolution on the City Commission agenda to accept the wastewater treatment plant and the filter project at the next meeting.
- The effluent water coming from the new wastewater treatment plant is in full compliance with the TCEQ parameters. The application submitted to TCEQ for the renewal of the permit of the old wastewater treatment plant has been approved on the same parameters.
- SLC has made good progress on the sewer lines project. They are still behind approximately 30 days.
- One of the applications submitted to USDA was for solar power for City Hall, the library and the fire station. USDA has asked that the City submit a full application on this project. The City also submitted an application for a training facility and they have asked that the City submit a full application on this project, as well. All the other applications have been submitted to Temple for review.
- Disaster Recovery Funded Projects Staff will be meeting with the engineering staff selected to do the environmental on the paving package on Friday.
- The City submitted an application for Solar Powered Street Lighting through Congressman Ruben Hinojosa's office.

Mayor Steve Brewer declared the public comments session open. No one signed up to speak before the Commission, so Mayor Brewer declared the public comment session closed.

#### **ACTION FOR ADJOURNMENT**
