## REVIEW AND APPROVE MINUTES OF PROCEEDINGS OF THE PREVIOUS MEETING OF THE LFEDC HELD ON TUESDAY, MARCH 26, 2013

After review of the minutes, Ms. Angelica P. Baldivia moved to approve the minutes of proceedings of the previous meeting of the LFEDC held on March 26, 2013, as presented in written form. Ms. Lori Weaver seconded the motion, and the motion carried by unanimous vote of the board members present.

## FINANCIAL REPORTS FOR THE MONTHS OF MARCH THROUGH JULY 2013

Finance Director Ms. Maria Chavero reviewed the financial reports for the months of March through July 2013. She reviewed the revenues and expenditures for the months of March through June, and then both the monthly and year-to-date figures for the report for the month of July. Ms. Chavero then reviewed the Analysis of Current EDC Sales Tax Collection Report which reflected an average monthly collection of \$22,210. She also reviewed the Comptroller's reports for each of the months from April through August which showed an increase in sales tax collections of 2.68% year-to-date. After review, Board President Ms. Betty Jo Dunlap announced that the reports would be filed for audit.

## BUDGET WORKSHOP FOR FY 2013/2014 FOR THE LA FERIA ECONOMIC DEVELOPMENT CORPORATION, INC.

Finance Director Ms. Maria Chavero reviewed the proposed budget with the board members. She said the LFEDC is in good financial shape. She discussed that the LFEDC would be seeking a loan to purchase the property north of Dodd Lane on FM 506 next to the location of the Safe Dome and the \$35,000 down payment would come from the LFEDC fund balance. She also said the LFEDC is considering an incentive grant in the amount of \$15,000 for a new business, and it will be providing \$25,000 funding for the Northwest Park. Ms. Chavero then reviewed the Revenues and Expenditures by line item. City Manager/Executive Director Mr. Sunny K. Philip said this is a workshop only and staff was not asking the board to make any decisions tonight. There was no action needed on this item.
