- Water and Wastewater System Improvements projects

City Manager Sunny K. Philip reported the following:

- SLC Construction Project the sewer lines have gone through inspection, the South Beddoes lift station is fully operational and is working good. Thursday or Friday, the North Beddoes lift station will be ready for start up and final inspection soon. The contractor fell behind on payments to subcontractors and the bonding company took over and they brought in a new contractor.
- The Generators Project Metro Electric has done a good job.
- The Filter Replacement Project the project is moving along good. The contractor is ahead of schedule.
- The City has submitted several applications to the Texas Water Development Board (TWDB) for water and wastewater projects totaling 24 million dollars. The City qualified for 24 million dollars, but after TWDB reviewed the funds available, they notified the City that the amount they would fund would be more in the range of 15 or 16 million dollars.
