CONSIDER AND TAKE ACTION TO APPROVE MINUTES OF PROCEEDINGS OF THE PREVIOUS REGULAR MEETING OF THE LA FERIA UTILITIES BOARD HELD ON AUGUST 10, 2010

After review of the minutes, Ms. Betty Jo Dunlap moved to approve the minutes of proceedings of the previous regular meeting of the La Feria Utilities Board held on Tuesday, August 10, 2010. Mr. Ovidio Saldivar seconded the motion, and the motion carried by unanimous vote of the Board members present.

REVIEW AND TAKE ACTION TO APPROVE BUDGET AMENDMENT FOR FY 2009-2010

Finance Director Ms. Maria Chavero reviewed the budget amendment for FY 2009-2010. The total revenues amendment figure was \$6,229,532.00 The total expenditure amendment figure was \$5,983,070.00. The revenue was \$246,462.00 over the

expenditures. Mr. Philip discussed the various grants that have been received for water and wastewater improvements that ranged into the millions of dollars. After discussion and all questions answered, Ms. Betty Jo Dunlap moved to approve the budget amendment for FY 2009-2010. Mr. Ovidio Saldivar seconded the motion, and the motion carried by unanimous vote of the board members present.

BUDGET WORKSHOP

Finance Director Ms. Maria Chavero presented a rough draft of the Waterworks and Sewer System Fund Budget for FY 2010-2011. The total revenues figure was \$2,357,260.00; the total expenditures were \$3,820,742.00 for a total of (\$1,463,482.00) expenditures over revenues. Ms. Chavero reviewed the proposed budget by line item. Much discussion followed as to the cost of electrical power to operate the new wastewater treatment plant, and how it can be lessened. One idea is to share the load between the lagoon system and the new wastewater treatment plant. Another would be the installation of solar panels which would reduce the electricity bill. There was no action needed on this item.

REPORT BY STAFF

• Water and Wastewater System Improvements projects

City Manager Sunny K. Philip reported the following:

- SLC Contractor is finalizing the lift stations.
- R.P. Constructors has begun work on the Filter Replacement Project at the Water Treatment Plant. They poured the concrete on one structure and are getting ready to do the second structure.
- The generators' concrete slabs are done.

PUBLIC COMMENTS

Board Chairman Mr. Adolfo Lopez declared the public comment session open. No one signed up to speak before the board, so Mr. Lopez declared the public comment session closed.
