A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LA FERIA, CAMERON COUNTY, TEXAS, ORDERING A GENERAL ELECTION IN THE CITY OF LA FERIA ON SATURDAY MAY 14, 2011, FOR THE PURPOSE OF ELECTING A CITY COMMISSIONER FOR POSITION NUMBER THREE, A CITY COMMISSIONER FOR POSITION NUMBER FOUR, AND A CITY COMMISSIONER FOR POSITION NUMBER FIVE ON THE CITY COMMISSION TO HOLD OFFICE FOR A PERIOD OF THREE YEARS, DESIGNATING POLLING PLACES, PROVIDING FOR **DESIGNATION** OFFICERS FOR SUCH ELECTION, ORDERING NOTICE ELECTION TO BE GIVEN AS PRESCRIBED BY LAW IN CONNECTION WITH SUCH ELECTION, AND PROVIDING FOR OTHER MATTERS RELATING TO THE GENERAL ELECTION.

WHEREAS, the laws of the State of Texas and the Home Rule Charter of the City of La Feria, Texas require that the City of La Feria General Election be held on the second Saturday in May; and A PARACE TALA OF THE SEES CONDENSATION OF FIRST OFFIA

WHEREAS, said second Saturday in May 2011 falls on May 14, 2011; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LA FERIA, TEXAS:

That notice is hereby given that a General City Election will be held in and throughout the City of La Feria, Texas, on Saturday, May 14, 2011 at which there shall be submitted to the duly qualified resident electors of the City as to the election of a city commissioner for City Commissioner Position Three, a city commissioner for City Commissioner Position Four, and a city commissioner for City Commissioner Position Five.

inna alikerityofile That the City Secretary is the early voting clerk for the election pursuant to Sec. 83.005 of the Election Code and that the City Secretary may appoint deputy early voting clerks to assist with early voting pursuant to Sec. 83.031 and Sec. 83.032. WHEREAS, on.

That the City Secretary is hereby directed to cause notice to be given of said election by publication in a newspaper with a general circulation in La Feria, in accordance with the City Home Rule Charter and State Election Code and all necessary orders and writs for said election shall be issued by the proper authority. e^a for a term words **u** ter 字質型

That applications to have the name of a candidate placed on the ballot may not be filed earlier than thirty (30) days before the deadline prescribed by the State Election Code for filing applications with the City Secretary at City Hall, 115 East Commercial Avenue, La hour Feria, Texas and that the earliest date for a candidate to file same will be February 12, 2011, at 8:00 AM, with the last day for filing to be on the 61st day before the election (extended,

from the 62nd day), March 14, 2011, at 5:00 PM, in accordance with Election Code Secs. 1.006, 143.007 (a), and 144.005 (a).

That the order in which the names of the candidates for each position are to be printed on the ballot shall be determined by a drawing of names to be conducted on March 22, 2011, at 5:30 PM.

That the election shall be held at W.B. Green Junior High School, located at 501 North Canal Street on May 14, 2011, during the hours of 7:00 AM to 7:00 PM.

That in accordance with Sec. 123.001 of the Texas Election Code, the use of the paper ballot is hereby adopted for the early voting and regular voting for the election of May 14, 2011.

That the City of La Feria will use two (2) ES&S Auto Mark Voter Assist Terminals, version 1.0.121 and the Model 100 Scanner (Precinct Counter), version 5.0.0, both being state certified provided such machines are available through Cameron County, Texas, for the City's General Election to be held on May 14, 2011 for the Early Voting period starting May 2 through May 10 and also on Election Day, May 14, 2011.

That the City Secretary shall serve as the General Custodian of election records for voting precincts.

That Mr. Mario Gonzales is hereby appointed Election Presiding Judge and Ms. Betty Jo Dunlap as Alternate Presiding Judge for said election:

That any further election staff appointments for this election shall be done in accordance with the provisions of the Texas Election Code and the City of La Feria Home Rule Charter.

That the personal appearance early voting for the above designated election shall be at the La Feria Fire Station, located at 200 E. Business Highway 83, La Feria, Texas 78559 beginning May 2 through May 10, 2011 (Except Federal, State and Local Holidays). Early voting hours are as follows:

Monday through Friday, May 2 through May 6, 2011

8:00 A.M. to 4:30 P.M.

Saturday, May 7, 2011

10:00 A.M. to 2:00 P.M.

Sunday May 8, 2011

2:00 P.M. to 6:00 P.M.

Monday and Tuesday, May 9 and May 10, 2011 (designated 12 hour days) – 8:00 A.M. to 8:00 P.M.

Ballot applications and ballots voted by mail are to be sent to the Early Voting Clerk, to the address of 115 East Commercial Avenue, La Feria, TX 78559.

That the early voting ballots shall be canvassed by the Early Voting Ballot Board, said Board being comprised of the following persons: (1) Ms. Betty Jo Dunlap, Chairman (2) Ms. Lucy Hernandez, Vice Chairman/Member and (3) Ms. Mary Villarreal, Member; and

That if any provisions of this resolution or the Charter of the City are in conflict with the Texas Election Code, the terms and provisions of the Texas Election Code shall supersede.

That it is hereby officially found and determined that the meeting at which this resolution is passed is open to the public as required by law, and that public notice of time, place, and purpose of said meeting was given as required by law.
