

RESOLUTION 2011-29

**A RESOLUTION OF THE CITY OF LA FERIA, TEXAS
APPOINTING ONE NEW MEMBER TO THE PLANNING &
ZONING COMMISSION**

WHEREAS, Article 14.02 of the La FERIA Code of Ordinances as amended establishes a Planning & Zoning Commission; and

WHEREAS, the La FERIA Planning and Zoning Commission is comprised of six (6) members identified by place numbers one (1) through six (6), each serving a three (3) year term; and

WHEREAS, the quorum of the Planning and Zoning Commission comprised of six members is four members and the quorum for a Planning and Zoning Commission comprised of seven members is also four members, and it is easier to attain attendance of four out of seven members rather than four out of six members; and

WHEREAS, the La FERIA City Commission considered and approved Ordinance 2010-17 on November 16, 2010 amending Section 14.02.002 – Memberships and Appointment and Section 14.02.003 Terms of Office of the Code of Ordinances; and

WHEREAS, the aforementioned amendment increased the total number of members on the Planning and Zoning Commission from six (6) to seven (7), thereby creating a vacancy on the board; and

WHEREAS, the La FERIA City Commission is responsible for the appointment of the Planning & Zoning Commissioners; and

WHEREAS, the following persons were appointed to the following terms on the Planning & Zoning Commission:
