

**RESOLUTION 2011-48**

**A RESOLUTION OF THE CITY OF LA FERIA, TEXAS  
APPOINTING ONE NEW MEMBER TO THE PLANNING &  
ZONING COMMISSION**

**WHEREAS**, Article 14.02 of the La FERIA Code of Ordinances as amended establishes a Planning & Zoning Commission; and

**WHEREAS**, the La FERIA City Commission considered and approved Ordinance 2010-17 on November 16, 2010 amending Section 14.02.002 – Memberships and Appointment and Section 14.02.003 Terms of Office of the Code of Ordinances to increase the number of board members; and

**WHEREAS**, the La FERIA Planning and Zoning Commission is now comprised of seven (7) members identified by place numbers one (1) through seven (7), each serving a three (3) year term; and

**WHEREAS**, Board Member Marco Rodriguez whose term expires on October 1, 2012 has submitted his resignation from the Planning and Zoning Commission effective immediately, thereby, creating a vacancy on the board; and

**WHEREAS**, Mr. Manuel Briones has submitted an application to serve on the Planning and Zoning Commission and is willing to serve the La FERIA community in that capacity; and

**WHEREAS**, the La FERIA City Commission is responsible for the appointment of the Planning & Zoning Commissioners; and


