

Road, to change from the temporary zoning district of R-1 Single Family Residential (9,000 square foot minimum lot size) to R-3 Single Family Residential (5,000 sq. ft. minimum lot size).

Consideration and possible action to adopt ordinance to change the zoning district of the 15.82 acres comprising of Blocks 34 and 35, of Solis Subdivision, said property being located on the east side of FM 2556 and north of Mile 8 N. Road, and shown on Exhibit A of the Ordinance, to change the zoning district from R-1 Single Family Residential (9,000 square foot minimum lot size) to R-3 Single Family Residential (5,000 sq. ft. minimum lot size).
