MINUTES OF PROCEEDINGS CITY COMMISSION Tuesday, September 25, 2012

Be it known that the City of La Feria City Commission met in regular session on Tuesday, September 25, 2012, at 6:30 P.M. in the City Commission Meeting Room, 115 E. Commercial Avenue, La Feria, Texas 78559. The purpose of said meeting was to consider and take action on those items of City Business as was duly posted by agenda in accordance with State Open Meetings Law. At 6:30 P.M., Mayor Steve Brewer asked Commissioner Victor Gonzalez, Jr. to give the invocation. After the invocation, Mayor Brewer led everyone present in reciting the Pledge of Allegiance to the Flag of the United States of America. He then declared that a quorum of the City Commission was present and called the meeting to order.

CONSIDER AND TAKE ACTION TO APPROVE A RESOLUTION DOCUMENTING THE ANNUAL REVIEW AND APPROVING ANY MODIFICATION NECESSARY OF THE CITY OF LA FERIA INVESTMENT POLICY

There were no modifications to the City of La Feria Investment Policy during the annual review. Commissioner Lori Weaver moved to read the resolution by caption only, in lieu of reading it in its entirety. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commissioners present. City Attorney Mr. Richard S. Talbert read the caption of Resolution 2012-40. After reading of the caption, Commissioner Lori Weaver moved to approve Resolution 2012-40 documenting the annual review and approving any modification necessary of the City of La Feria Investment Policy. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

CONSIDER AND TAKE ACTION TO APPROVE RESOLUTION OF THE CITY OF LA FERIA, TEXAS, APPROVING THE TAX ROLL FOR THE CITY OF LA FERIA, AND AUTHORIZING THE CAMERON COUNTY TAX ASSESSOR/COLLECTOR TO BEGIN THE COLLECTION OF TAXES FOR TAX YEAR 2012

This item was tabled at the last City Commission meeting held on September 11, 2012. Commissioner Lori Weaver moved to read the resolution by caption only, in lieu of reading it in its entirety. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commissioners present. City Attorney Mr. Richard S. Talbert read the caption of Resolution 2012-41. After reading of the caption, Commissioner John Hernandez moved to approve Resolution 2012-41 approving the tax roll for the City of La Feria, and authorizing the Cameron County Tax Assessor/Collector to begin the collection of taxes for tax year 2012. Commissioner Lori Weaver seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

PUBLIC HEARING TO RECEIVE INPUT ON THE REQUEST BY SUNRISE TERRACE, LP, OWNER OF 15.82 ACRES COMPRISING OF BLOCKS 34 AND 35 OF SOLIS SUBDIVISION, SAID PROPERTY BEING LOCATED ON THE EAST SIDE OF FM 2556 AND NORTH OF MILE 8 N. ROAD, TO CHANGE FROM THE TEMPORARY ZONING DISTRICT OF R-1 SINGLE FAMILY RESIDENTIAL (9,000 SQUARE FOOT MINIMUM LOT SIZE) TO R-3 SINGLE FAMILY RESIDENTIAL (5,000 SQ. FT. MINIMUM LOT SIZE)

Mayor Steve Brewer declared the public hearing open at 6:35 P.M. City Attorney Mr. Richard S. Talbert said this is for rezoning of the Sunrise Terrace Subdivision. The change is from the temporary zoning district of R-1 Single Family Residential to R-3 Single Family Residential. Mr. Talbert said that according to Planning and Community Development Director Ms. Irene Szedlmayer all notices were published and posted and the Planning and Zoning Commission met and considered this item. They are recommending the change. There being no further comments, Mayor Steve Brewer declared the public hearing closed at 6:36 P.M.

CONSIDERATION AND POSSIBLE ACTION TO ADOPT ORDINANCE TO CHANGE THE ZONING DISTRICT OF THE 15.82 ACRES COMPRISING OF BLOCKS 34 AND 35, OF SOLIS SUBDIVISION, SAID PROPERTY BEING LOCATED ON THE EAST SIDE OF FM 2556 AND NORTH OF MILE 8 N. ROAD, AND SHOWN ON EXHIBIT A OF THE ORDINANCE, TO CHANGE THE ZONING DISTRICT FROM R-1 SINGLE FAMILY RESIDENTIAL (9,000 SQUARE FOOT MINIMUM LOT SIZE) TO R-3 SINGLE FAMILY RESIDENTIAL (5,000 SQ. FT. MINIMUM LOT SIZE)

Mr. Richard S. Talbert said that Planning and Community Development Director Ms. Irene Szedlmayer said that the change in the ordinance is consistent with the Comprehensive Plan, and staff is recommending adoption. Commissioner John Hernandez moved to read the ordinance by caption only, in lieu of reading it in its entirety. Commissioner Victor Gonzalez, Jr. seconded the motion, and the motion carried by unanimous vote of the City Commissioners present. City Attorney Mr. Richard S. Talbert read the caption of Ordinance 2012-12. After reading of the caption, Commissioner Victor Gonzalez, Jr. moved to approve Ordinance 2012-12 changing the zoning district of the 15.82 acres comprising of Blocks 34 and 35, of Solis Subdivision, said property being located on the east side of FM 2556 and north of Mile 8 N. Road, and

shown on Exhibit A of the Ordinance, to change the zoning district from R-1 Single Family Residential (9,000 square foot minimum lot size) to R-3 Single Family Residential (5,000 sq. ft. minimum lot size). Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

REVIEW AND POSSIBLE ACTION ON THE PROPOSED FINAL PLAT FOR SUNRISE TERRACE SUBDIVISION, APPROXIMATELY 15.82 ACRES OUT OF BLOCKS 34 AND 35 OF SOLIS SUBDIVISION, SAID PROPERTY BEING LOCATED ON THE EAST SIDE OF FM 2556 AND NORTH OF MILE 8 N. ROAD

Planning and Community Development Director Ms. Irene Szedlmayer distributed a revised plat to the City Commission. She said some of the lots are longer, some easements are wider. Ms. Szedlmayer said the Planning and Zoning Commission is recommending approval and staff is recommending approval. She added that the plat meets the Subdivision Ordinance requirements and is consistent with the Comprehensive Plan. Commissioner Angelica P. Baldivia inquired if there would be sidewalks. Ms. Szedlmayer responded that there would be 4 foot sidewalks all around the streets on both sides of the 30 ft. streets. Commissioner Lori Weaver moved to approve the Final Plat for Sunrise Terrace Subdivision, approximately 15.82 acres out of Blocks 34 and 35 of Solis Subdivision, said property being located on the east side of FM 2556 and North of Mile 8 N. Road. Commissioner Victor Gonzalez, Jr. seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.
