

**RESOLUTION 2012-48**

**A RESOLUTION OF THE CITY OF LA FERIA, TEXAS RE-  
APPOINTING TWO MEMBERS TO THE PLANNING & ZONING  
COMMISSION**

**WHEREAS**, Article 14.02 of the La Feria Code of Ordinances as amended establishes a Planning & Zoning Commission; and

**WHEREAS**, the La Feria City Commission considered and approved Ordinance 2010-17 on November 16, 2010 amending Section 14.02.002 – Memberships and Appointment and Section 14.02.003 Terms of Office of the Code of Ordinances to increase the number of board members; and

**WHEREAS**, the La Feria Planning and Zoning Commission is now comprised of seven (7) members identified by place numbers one (1) through seven (7), each serving a three (3) year term; and

**WHEREAS**, the La Feria City Commission is responsible for the appointment of the Planning & Zoning Commissioners; and

**WHEREAS**, the following persons were appointed to the following terms on the Planning & Zoning Commission:

**WHEREAS**, the terms of Board Members Mr. Manuel Briones, Mr. George Hernandez, and Mr. George E. Lazaro expired on October 1, 2012; and

**WHEREAS**, Sec. 14.02.003 Terms of Office of the La Feria Code of Ordinances stipulates that no member shall serve more than three (3) consecutive terms; and

**WHEREAS**, Board Member George E. Lazaro has served three (3) consecutive terms and is no longer eligible for re-appointment to the Planning and Zoning Commission thereby creating a vacancy; and

**WHEREAS**, a new member needs to be appointed to take the place of Mr. Lazaro on the Board; and

**WHEREAS**, Board Members Mr. Manuel Briones and Mr. George Hernandez, whose terms have expired, are still eligible to serve on the Planning and Zoning Commission and have consented to serve another term,


**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LA FERIA, TEXAS, THAT MR. MANUEL BRIONES AND MR. GEORGE HERNANDEZ BE RE-APPOINTED TO SERVE ANOTHER THREE YEAR TERM ON THE PLANNING & ZONING COMMISSION AND THAT THE FOLLOWING IS A LISTING OF THE LA FERIA PLANNING & ZONING COMMISSION MEMBERS, THEIR PLACES AND TERMS:**


