At 5:17 P.M., Board Chairman Mr. Adolfo Lopez asked all present to rise and recite aloud the Pledge of Allegiance to the Flag of the United States of America. After this was done, Mr. Lopez declared that a quorum of the Board was present and called the meeting to order.

### REVIEW AND TAKE ACTION TO APPROVE MINUTES OF PROCEEDINGS OF THE SPECIAL MEETING OF THE LA FERIA UTILITIES BOARD HELD ON TUESDAY, JULY 24, 2012

## FINANCIAL REPORTS FOR THE MONTH OF JULY 2012

Finance Director Ms. Maria Chavero reviewed the financial reports with the board, reviewing both the monthly and year-to-date figures for the month of July. Ms. Chavero

then reviewed the Performance Indicators for the month. After review and all questions answered, Board Chairman Mr. Adolfo Lopez announced that the reports would be filed for audit.

# BUDGET WORKSHOP FOR CITY OF LA FERIA WATERWORKS AND SEWER SYSTEM BUDGET FOR FY 2012-2013

Finance Director Ms. Maria Chavero reviewed some of the highlights of the proposed budget with the Board. She said that this is only a preliminary budget and she discussed how the budget was balanced by using some of the grant administration money from the two large Texas Water Development Board projects and the anticipated addition of accounts due to the development of the 80-unit apartment complex known as Sunflower Estates. Ms. Chavero said the plan is to increase the incremental rates of the water and sewer rates, unless the Board would rather increase the base rate or a combination of both. Water and sewer rates were last increased in 2010; there was no increase last year. Ms. Chavero said expenses would go up due to the cost of living estimated at approximately 4%. A discussion followed concerning the estimated increase in revenues by 17% which was an estimate of the overall increase in revenues from various sources and not an increase strictly due to the water and sewer rate structure. The Board requested that staff bring back the numbers on the rates and the numbers on the solar panel projects. Since this was a workshop, there was no action needed on this item. The budget would need approval at the next Utilities Board Meeting on September 11, 2012.

#### **PUBLIC COMMENTS**

Board Chairman Mr. Adolfo Lopez declared the public comment session open. No one signed up to speak before the board, so Mr. Lopez declared the public comment session closed.

#### ACTION FOR ADJOURNMENT

There being no further business to conduct, Mr. Ralph Muse moved for adjournment of the meeting. Ms. Betty Jo Dunlap seconded the motion, and the motion carried by unanimous vote of the board members present.
