Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

REVIEW AND TAKE ACTION TO APPROVE MINUTES OF PROCEEDINGS OF THE REGULAR MEETING OF THE CITY COMMISSION HELD ON TUESDAY, NOVEMBER 5, 2013 After review of the minutes, Commissioner John Betancourt moved to approve the minutes of proceedings of the regular meeting of the City Commission held on Tuesday, November 5, 2013. CONSIDER AND TAKE ACTION TO APPROVE OR DENY AN ORDINANCE DESIGNATING DECEMBER 14, 2013 AS THE DATE FOR THE 15TH ANNUAL CHRISTMAS PARADE IN LA FERIA AND AUTHORIZING THE TEMPORARY CLOSING OF CERTAIN AND SPECIFIED STREETS WITHIN THE CITY OF LA FERIA FOR THE PURPOSE OF ENSURING THE SAFETY AND GENERAL WELFARE OF THE PUBLIC DURING THE 15TH ANNUAL CHRISTMAS PARADE ON SAID DATE OR IN THE EVENT OF INCLEMENT WEATHER ANY OTHER ALTERNATE DATE APPROVED BY THE CITY MANAGER

City Manager Mr. Sunny K. Philip said that this ordinance is similar to the ordinance approved in the past for the temporary closing of the streets for the Christmas Parade. Commissioner Victor Gonzalez, Jr. moved to read the ordinance by caption only, in lieu of reading it in its entirety. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commissioners present. City Manager Mr. Sunny K. Philip read the caption of Ordinance 2013-18. After reading of the caption, Commissioner Victor Gonzalez, Jr. moved to approve Ordinance 2013-18 designating December 14, 2013 as the date for the 15th Annual Christmas Parade in La Feria and authorizing the temporary closing of certain and specified streets within the City of La Feria for the purpose of ensuring the safety and general welfare of the public during the 15th Annual Christmas Parade on said date or in the event of inclement weather any other alternate date approved by the City Manager. Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.
