Be it known that the City of La Feria City Commission met in regular session on **Tuesday, February 26, 2013, at 6:30 P.M.** in the City Commission Meeting Room, 115 E. Commercial Avenue, La Feria, Texas 78559. At 6:37 P.M., Mayor Pro Tem Lori Weaver gave the invocation. After the invocation, Mayor Pro Tem Lori Weaver led everyone present in reciting the Pledge of Allegiance to the Flag of the United States of America. She then declared that a quorum of the City Commission was present and called the meeting to order.

CONSIDER AND TAKE ACTION TO APPROVE OR DENY RESOLUTION OF THE CITY OF LA FERIA AUTHORIZING THE INCLUSION OF WEEKEND VOTING TO BE HELD ON SATURDAY, MAY 4 AND SUNDAY, MAY 5, 2013 AND ESTABLISHING HOURS FOR SATURDAY, MAY 4 TO BE FROM 10:00 A.M. TO 2:00 P.M. AND SUNDAY, MAY 5, FROM 2:00 P.M. TO 6:00 P.M., AND DESIGNATING THAT THE EXTENDED HOURS (12-HOUR DAYS) BE HELD ON MONDAY, MAY 6 AND TUESDAY, MAY 7, 2013 FOR THE CITY GENERAL ELECTION 2013 AND ESTABLISHING HOURS FOR MONDAY, MAY 6 AND TUESDAY, MAY 7, TO BE FROM 8:00 A.M. TO 8:00 P.M. City Manager Sunny K. Philip explained that the resolution is the City's effort to provide more and better opportunities for the voters to vote. Commissioner John Betancourt moved to read the resolution by caption only, in lieu of reading it in its entirety. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by

unanimous vote of the City Commissioners present. City Attorney Mr. Richard S. Talbert read the caption of Resolution 2013-05. After reading of the caption, Commissioner John Betancourt moved to approve Resolution 2013-05 authorizing the inclusion of weekend voting to be held on Saturday, May 4 and Sunday, May 5, 2013 and establishing hours for Saturday, May 4 to be from 10:00 A.M. to 2:00 P.M. and Sunday, May 5, from 2:00 P.M. to 6:00 P.M., and designating that the extended hours (12-hour days) be held on Monday, May 6 and Tuesday, May 7, 2013 for the City General Election 2013 and establishing hours for Monday, May 6 and Tuesday, May 7, to be from 8:00 A.M. to 8:00 P.M. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

CONSIDER AND TAKE ACTION TO APPROVE OR DENY RESOLUTION OF THE CITY COMMISSION OF LA FERIA, CAMERON COUNTY, TEXAS, ORDERING A GENERAL ELECTION IN THE CITY OF LA FERIA ON SATURDAY, MAY 11, 2013 FOR THE PURPOSE OF ELECTING A MAYOR AND A CITY COMMISSIONER FOR POSITION NUMBER ONE, A CITY COMMISSIONER FOR POSITION NUMBER TWO ON THE CITY COMMISSION TO HOLD OFFICE FOR A PERIOD OF THREE YEARS, DESIGNATING POLLING PLACES, PROVIDING FOR DESIGNATION OF OFFICERS FOR SUCH ELECTION, ORDERING NOTICE OF ELECTION TO BE GIVEN AS PRESCRIBED BY LAW IN CONNECTION WITH SUCH ELECTION, AND PROVIDING FOR OTHER MATTERS RELATING TO THE GENERAL ELECTION

City Manager Sunny K. Philip explained that this resolution is required for ordering the City General Election and that it has the same language as previous election resolutions other than this calls for the election of the Mayor and Commissioner Position 1 and Commissioner Position 2, as well as the date changes. Commissioner John Betancourt moved to read the resolution by caption only, in lieu of reading it in its entirety. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commissioners present. City Attorney Mr. Richard S. Talbert read the caption of Resolution 2013-06. After reading of the caption, Commissioner John Betancourt moved to approve Resolution 2013-06 ordering a General Election in the City of La Feria on Saturday, May 11, 2013 for the purpose of electing a Mayor and a City Commissioner for position number one, a City Commissioner for position number two on the City Commission to hold office for a period of three years, designating polling places, providing for designation of officers for such election, ordering notice of election to be given as prescribed by law in connection with such election, and providing for other matters relating to the General Election. Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

REVIEW AND APPROVE THE FINAL PLAT FOR THE FIRE STATION SUBSTATION

City Manager Sunny K. Philip explained that the plat was presented at a previous City Commission meeting, but the land was not in the City's name at that time. It has since been donated to the City by Steve Bauer and the property is in the City's name. Commissioner Angelica P. Baldivia moved to approve the final plat for the fire station Substation. Commissioner Victor Gonzalez, Jr. seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

PUBLIC HEARING ON THE REQUEST BY DESIDERIO MARTINEZ FOR A SPECIFIC USE PERMIT (SUP) TO ALLOW THE LATE-HOURS (UNTIL 2 A.M.) SALE OF ALCOHOLIC BEVERAGES AT JIMMY'S SPORTS BAR, 312W. FIRST STREET, LA FERIA. THE LEGAL DESCRIPTION OF THE PROPERTY IS THE WEST 11' OF LOT 4 AND ALL OF LOTS 5 AND 6, BLOCK G, POTTER WATSON SUBDIVISION, CAMERON COUNTY, TX.

Planning and Community Development Director Ms. Irene Szedlmayer explained that the City Commission had approved a late hours SUP in 2010 for this location, but it was never used. City Manager Sunny K. Philip said that if the bar is open during regular hours only, the staff can approve the request, but if it is for late hours, it needs to come before the City Commission for approval. Mayor Pro Tem Lori Weaver declared the public hearing open at 6:51 P.M. Mr. Desi Martinez was present for the public hearing and requested that the City Commission consider his request for late hours for the entire week. Staff recommendation was to allow late hours on Friday and Saturday only. There was no one else present to speak for or against this request, so Mayor Pro Tem Lori Weaver declared the public hearing closed at 6:57 P.M.

Commissioner Angelica P. Baldivia said that she would like to request that this item be tabled for a later date. She said that she also liked the idea of staff's recommendation of granting the Friday and Saturday late hours, with the addition of the other days of the week at a later date if everything went well with the Friday and Saturday late hours. More discussion followed concerning the granting of late hours to R & R Tavern for the entire week and also the impact of the late hours on the surrounding residences. Comparison of the neighborhoods and parking were discussed. After discussion, Commissioner Victor Gonzalez, Jr. moved to approve the request by Desiderio Martinez for a Specific Use Permit (SUP) to allow the late hours (until 2 a.m.) sale of alcoholic beverages at Jimmy's Sports Bar, 312 W. First Street, La Feria; legal description of the property is the west 11' of Lot 4 and all of Lots 5 and 6, Block G. Potter Watson Subdivision, Cameron County, TX. Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.
