After the invocation, Mayor Brewer led everyone present in reciting the Pledge of Allegiance to the Flag of the United States of America. He then declared that a quorum of the City Commission was present and called the meeting to order.

After review of the minutes, Commissioner Lori Weaver moved to approve the minutes of proceedings of the special meeting of the City Commission held on Wednesday, July

3, 2013. Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commission.

REVIEW BID TABULATION OF BIDS RECEIVED FOR THE LA FERIA FIRE STATION EXPANSION AND SUBSTATION, AND TAKE ACTION TO AWARD CONTRACT TO THE LOWEST, MOST QUALIFIED RESPONSIBLE BIDDER

City Manager Mr. Sunny K. Philip said the City advertised for bids for the Fire Station Expansion and Substation Project and seven contractors responded to the advertisement. The bids were as follows:

Mr. Philip said the lowest bid was Vision Construction in the amount of \$979,656.62 to be completed in 120 days. Mr. Luis Garcia, Senior Project Manager with Vision Construction was present at the meeting and gave a brief overview of their company. Their Corporate Office is in San Antonio, but they have offices in Pharr, Laredo, and Del Rio. Mr. Garcia said his company is very comfortable with the number they have submitted and they have no doubt that they would be able to complete the project in 120 days. Staff recommended award of contract to the lowest bidder subject to Vision Construction providing the appropriate bonding and insurance and further references. Mrs. Angelica P. Baldivia moved to award contract to the lowest, most qualified responsible bidder Vision Construction in the amount of \$979,656.62 subject to the Company providing the appropriate bonding and insurance and further references. Commissioner Lori Weaver seconded the motion, and the motion carried by unanimous vote of the City Commission.

CONSIDER AND TAKE ACTION TO APPROVE OR DENY RESOLUTION OF THE CITY OF LA FERIA DECLARING CERTAIN EQUIPMENT AS SURPLUS PROPERTY AND AUTHORIZING THE SALE OF A 1995 FORD F-150 PICKUP TRUCK, V.I.N. 2FTDF15Y9SCA22630 AND A 1993 GMC 3500 PICKUP TRUCK, V.I.N. 1GDHK33N5PJ723431 TO THE LA FERIA INDEPENDENT SCHOOL DISTRICT

City Manager Mr. Sunny K. Philip explained that when the City Commission approved the previous budget, they approved new vehicles and the old vehicles they replaced are sitting in the warehouse. Mr. Philip said the La Feria Independent School District is interested in the used vehicles, and they have agreed to purchase the two vehicles mentioned above for the total sum of \$2,500.00. Commissioner John Betancourt moved to read the resolution by caption only in lieu of reading it in its entirety. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commission. City Attorney Mr. Richard S. Talbert read the caption of Resolution 2013-22. After reading of the caption, Commissioner John Betancourt moved to approve Resolution 2013-22 declaring the following two trucks as surplus property and authorizing the sale of a 1995 Ford F-150 Pickup Truck, V.I.N. 2FTDF15Y9SCA22630 and a 1993 GMC 3500 Pickup Truck, V.I.N. 1GDHK33N5PJ723431 to the La Feria Independent School District. Commissioner Victor Gonzalez, Jr. seconded the motion, and the motion carried by unanimous vote of the City Commission.

CONSIDER AND TAKE ACTION TO APPROVE OR DENY A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF LA FERIA AND THE LA FERIA INDEPENDENT SCHOOL DISTRICT (LFISD) REGARDING THE ESTABLISHMENT OF A HIGHER EDUCATION FACILITY IN THE COMMUNITY AND APPROVE COLLABORATION WITH THE LFISD FOR THE USE OF FACILITIES AND RESOURCES TO EFFECTUATE THE PROGRAM

City Manager Mr. Sunny K. Philip explained that this subject has been discussed for some time. He said the school attorney has not reviewed the Memorandum of Understanding (MOU) yet, and what he asked the Commission was to authorize the City Manager to submit the MOU to the school for their review and approval. Mayor Steve Brewer added that this would be good for the citizens of La Feria and will improve job opportunities and business development. Commissioner Lori Weaver moved to approve

a Memorandum of Understanding between the City of La Feria and the La Feria Independent School District (LFISD) regarding the establishment of a higher education facility in the Community and approve collaboration with the LFISD for the use of facilities and resources to effectuate the program and to authorize the City Manager to submit to the LFISD for their review and approval. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commission.

PUBLIC HEARING ON THE REQUEST BY JUAN M. MARTINEZ, DBA SAFEGUARD PEST CONTROL, FOR A SPECIFIC USE PERMIT (SUP) TO OPERATE A DISTRIBUTION CENTER/WAREHOUSE ON THE EAST 200' OF LOT 1, BLOCK 1, PEACEFUL ACRES SUBDIVISION, ALSO KNOWN AS 1601 SOUTH PARKER ROAD

Mayor Steve Brewer declared the public hearing open at 6:49 P.M. Planning and Community Development Director Ms. Irene Szedlmayer explained that Mr. Martinez is negotiating an agreement with Kingdom Hall to utilize their driveway to access his property. Ms. Szedlmayer said that if for any reason the agreement does not go through that Mr. Martinez's property has enough space for construction of a driveway to provide access to his property. Ms. Szedlmayer recommended that the SUP be issued for a period of five years instead of the one year default to the SUP if the Commission does not state otherwise. There being no further comments, Mayor Steve Brewer declared the public hearing closed at 6:55 P.M.

CONSIDERATION AND POSSIBLE ACTION TO APPROVE A SPECIFIC USE PERMIT (SUP) FOR JUAN M. MARTINEZ, DBA SAFEGUARD PEST CONTROL, TO OPERATE A DISTRIBUTION CENTER/ WAREHOUSE ON THE EAST 200' OF LOT 1, BLOCK 1 PEACEFUL ACRES SUBDIVISION, ALSO KNOWN AS 1601 SOUTH PARKER ROAD AND AUTHORIZING THE MAYOR TO EXECUTE THE ORDER

Commissioner Lori Weaver moved to approve a Specific Use Permit (SUP) for Juan M. Martinez, dba Safeguard Pest Control, to operate a distribution center/ warehouse on the east 200' of Lot 1, Block 1 Peaceful Acres Subdivision, also known as 1601 South Parker Road and authorizing the Mayor to execute the Order. Commissioner Angelica P. Baldivia seconded the motion, and the motion carried by unanimous vote of the City Commission.

OWNERS OF LAND APPRAISED FOR AD VALOREM TAX PURPOSES AS
AGRICULTURAL AND TO EXECUTE ON BEHALF OF THE CITY SAID
DEVELOPMENT AGREEMENTS, PURSUANT TO TEXAS LOCAL
GOVERNMENT CODE, SECTION 43.035

City Manager Mr. Sunny K. Philip explained that during the last three years the City of La Feria has not done any annexations, and the three year limit is about over. If the Commission approves this resolution, the City plans to have two public hearings, one on August 13, 2013 and the other on August 27, 2013, with the adoption of the ordinance to be on August 27, 2013. Ms. Irene Szedlmayer explained that based on the current size of the city which is 2,863 acres, the city can annex 859 acres or 30% of its land area. A lot

of the areas being proposed are Agricultural land and are eligible for Development Agreements, which even though the area may not be annexed into the city limits, it does extend the city limits. More discussion followed as to when the city needs to provide services to annexed areas. Ms. Irene Szedlmayer made a correction on Resolution 2013-23 which was to include the phrase, "to the same extent as similarly situated property elsewhere in the City" at the end of the fifth "WHEREAS". Commissioner Victor Gonzalez, Jr. moved to read the resolution by caption only in lieu of reading it in its entirety. Commissioner Lori Weaver seconded the motion, and the motion carried by unanimous vote of the City Commission. City Attorney Mr. Richard S. Talbert read the caption of Resolution 2013-23. After reading of the caption, Commissioner Lori Weaver moved to approve Resolution 2013-23 as amended with the phrase of "to the same extent as similarly situated property elsewhere in the City' directing the City Planning Department to prepare service plans for several areas being considered and evaluated for possible annexation to the City of La Feria and authorizing the City Manager to offer Development Agreements to owners of land appraised for ad valorem tax purposes as Agricultural and to execute on behalf of the City said Development Agreements pursuant to Texas Local Government Code, Section 43.035. Commissioner Victor Gonzalez, Jr. seconded the motion, and the motion carried by unanimous vote of the City Commission.

There were 30 or 40 student volunteers and there were 23 participants in the barbecue cook off. It was a great event. Mayor Brewer suggested that the inflatables be available later at night since a lot of people come later in the evening.
