

**RESOLUTION 2013-15**

**A RESOLUTION OF THE CITY OF LA FERIA, TEXAS, ELECTING A  
MAYOR PRO-TEMPORE OF THE CITY OF LA FERIA.**

**WHEREAS**, the City of La Feria is a duly incorporated Texas Municipal Corporation;  
and

**WHEREAS**, the City of La Feria is a Home Rule City with a Home Rule Charter; and

**WHEREAS**, the City of La Feria's Home Rule Charter, Section 2.09 requires the City  
Commission to elect one member of the City Commission to serve as Mayor Pro-  
Tempore to act in the Mayor's place and stead in the absence of the Mayor; and

**WHEREAS**, a City of La Feria General Election for 2013 was ordered by Resolution  
2013-06 to elect a Mayor, Commissioner Position 1, and Commissioner Position 2; and

**WHEREAS**, the incumbent City Commissioners did not receive any opponents to their  
candidacy; and

**WHEREAS**, the City of La Feria General Election was cancelled by the governing body  
by Order of Cancellation on March 12, 2013 in accordance with Section 2.051-2.053 of  
the Texas Election Code; and

**WHEREAS**, the incumbents were declared elected and have assumed their positions on  
the City Commission after filing the appropriate Statement of Elected Official and being  
duly sworn in and wish to elect one member to serve as Mayor Pro-Tempore in the  
absence of the Mayor; and


**WHEREAS**, Commissioner John Hernandez nominated Commissioner Lori Weaver to  
be elected as Mayor Pro-Tempore, which nomination was seconded by Commissioner  
Angelica P. Baldivia; and,

**WHEREAS**, Commissioner Lori Weaver accepted the nomination to serve as Mayor  
Pro-Tempore,

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF  
THE CITY OF LA FERIA, TEXAS, THAT COMMISSIONER LORI WEAVER  
HAS BEEN ELECTED AS MAYOR PRO-TEMPORE OF THE CITY OF LA  
FERIA, TEXAS, TO ACT IN THE MAYOR'S PLACE AND STEAD IN THE  
ABSENCE OF THE MAYOR UNTIL SUCH TIME AS A NEW MAYOR PRO-  
TEMPORE IS ELECTED.**


