- Water and Wastewater Systems Improvement Project and Financing

City Manager Sunny K. Philip reported the following:

- Water and Wastewater Systems Improvement Project Staff is working with the engineers and reviewing the plans. All this time has been spent in acquiring easements. The process now is to divide the 15 million dollar water and wastewater project into several different projects to make it manageable. Once the plans are finalized, they are sent to the Texas Water Development Board for their review.
- The City advertised the water meter purchase and held a pre-bid conference so that the bidders could ask questions. One of the requests was that the City extend the bid opening deadline to February 28, instead of February 14, 2013.
- Wastewater Treatment Plant Permit Renewal Jose Rodriguez who used to work with the Texas Commission on Environmental Quality (TCEQ) and now working as a consultant prepared the permit renewal and submitted the application with the appropriate fees to TCEQ. TCEQ has approved the permit renewal and now the City needs to advertise the notice in the next week or so..

Board Chairman Mr. Adolfo Lopez declared the public comment session open. No one signed up to speak before the board, so Mr. Lopez declared the public comment session closed.
