At 6:30 P.M., Mayor Victor Gonzalez, Jr. asked Commissioner Olga H. Maldonado to give the invocation. After the invocation, Mayor Victor Gonzalez, Jr. led everyone present in reciting the Pledge of Allegiance to the Flag of the United States of America. He then declared that a quorum of the City Commission was present and called the meeting to order.

PUBLIC COMMENTS

Mayor Victor Gonzalez, Jr. declared the public comments session open and acknowledged Ms. Candace Guillen. Ms. Guillen introduced herself as Treasurer of the Band Booster Club and introduced Ms. Susie Perez, Vice President, and Martha Hockaday, Secretary, of the Band Booster Club. Ms. Guillen thanked the City Commission for the wonderful welcome back that the band members received on Sunday morning at 2:30 A.M. as they returned from the Calallen area competition. They were

welcomed by the Police and Fire Department sirens as the students will be going to the State level next week, and the students were very pleased. Ms. Guillen also thanked the City for displaying the band banner on the City's banner post which she said was arranged by Mr. Ben Guerrero. And she also thanked the City for donating some fruit for the band's upcoming trip, as they strive to provide healthy foods for their students. Ms. Guillen said they will be decorating Main Street with the colors that the band members wear and asked for the City's help in encouraging businesses to post posters supporting the band. City Manager Mr. Sunny K. Philip said the private businesses have the option to do that and that they don't need permission from the City. Ms. Guillen, Ms. Perez, and Ms. Hockaday also shared other details of the performance and encouraged everyone to support the band and to be at the school as they return from competition whether or not they place in the finals. Mayor Gonzalez said the City would provide the same welcome on their return on Tuesday afternoon and that he would ask Mayor Pro Tem Esmeralda Lozano to contact the band director to coordinate a date for recognition of the band director and the band's accomplishment. Mayor Gonzalez thanked the ladies for their comments. No one else signed up to speak before the City Commission, so Mayor Gonzalez declared the public comment session closed.

REVIEW AND TAKE ACTION TO APPROVE THE MINUTES OF PROCEEDINGS OF THE REGULAR MEETING OF THE CITY COMMISSION HELD ON TUESDAY, OCTOBER 14, 2014

After review of the minutes, Commissioner Olga H. Maldonado moved to approve the minutes of proceedings of the regular meeting of the City Commission held on Tuesday, October 14, 2014. Commissioner Julian Guevara, Jr. seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

At this point in the meeting, Mayor Victor Gonzalez, Jr. announced that the City Commission would go into Executive Session for consultation with the City Attorney to discuss the next item on the agenda, Item #6 "Second Public Hearing on Annexation...." as well as Item #12, "Discussion and possible action on consideration of the creation of a City of La Feria Annexation Committee...." Mayor Victor Gonzalez, Jr. declared the meeting in executive session at 6:44 P.M. After executive session, Mayor Victor Gonzalez, Jr. declared the meeting back in open session at 7:29 P.M. Mayor Victor Gonzalez, Jr. announced that there would be no public hearing on annexation (Item #6) and that the Item #12 would be discussed when that item came up for consideration on the agenda.

SECOND PUBLIC HEARING ON ANNEXATION TO RECEIVE INPUT ON THE CITY OF LA FERIA'S ANNEXATION PROCEEDINGS TO ENLARGE AND EXTEND THE BOUNDARY LIMITS OF THE CITY OF LA FERIA TO INCLUDE THE FOLLOWING DESCRIBED TERRITORY TO-WIT:

BEGINNING AT A POINT ON THE SOUTH RIGHT-OF-WAY OF US HIGHWAY 281 AND THE WEST RIGHT-OF-WAY OF THE LA FERIA IRRIGATION DISTRICT NO. 3 MAIN CANAL; THEN NORTHWEST ALONG THE SOUTH RIGHT-OF-WAY OF US HIGHWAY 281 TO A POINT ON THE SOUTH RIGHT-OF-WAY OF US HIGHWAY 281 AND THE EAST RIGHT-OF-WAY OF RIVER DRIVE; THEN SOUTH ALONG THE EAST RIGHT-OF-WAY OF RIVER DRIVE TO THE NORTH BANK OF THE RIO GRANDE RIVER;

THEN SOUTHEAST ALONG THE NORTH BANK OF THE RIO GRANDE RIVER TO A POINT ON THE NORTH BANK OF THE RIO GRANDE RIVER AND THE SOUTHWEST CORNER OF THE BLOCK LINE BETWEEN TRACT R AND TRACT S; THEN NORTH ALONG THE BLOCK LINE BETWEEN TRACT R AND TRACT S TO THE POINT OF BEGINNING, WHICH AREA CONSISTS OF 995.24 ACRES

This public hearing was not held.

PUBLIC HEARING TO RECEIVE INPUT AND COLLECT EVIDENCE ON THE PROPOSED REZONING OF LOTS 7 THROUGH 31, BLOCK 4, ORIGINAL TOWNSITE OF THE CITY OF LA FERIA, TEXAS FROM C-1, RESTRICTED COMMERCIAL DISTRICT, TO C-2, GENERAL COMMERCIAL DISTRICT

City Manager Mr. Sunny K. Philip explained that this was a City initiated rezoning of Lots 7 through 31, Block 4, Original Townsite from C-1, Restricted Commercial District to C-2, General Commercial District. He said the Planning and Zoning Commission had a meeting last night, and they are recommending approval of the rezoning. Mayor Victor Gonzalez, Jr. inquired if the purpose of this rezoning is to address the parking requirements, and Mr. Philip responded that it was and also to authorize uses. Mayor Gonzalez inquired if anyone had requested a permit that prompted this rezoning. Mr. Philip responded that there has been some discussion with Aaron's Brake and Alignment. There were no other comments, so Mayor Victor Gonzalez, Jr. declared the public hearing closed at 7:35 P.M.

CONSIDER AND TAKE ACTION TO APPROVE OR DENY AN ORDINANCE OF THE CITY OF LA FERIA, TEXAS AMENDING CHAPTER 14, EXHIBIT A OF THE LA FERIA CODE OF ORDINANCES (THE ZONING ORDINANCE), AMENDING THE BOUNDARIES OF THE C-1 AND C-2 ZONING DISTRICTS ON THE OFFICIAL ZONING MAP OF THE CITY OF LA FERIA, AMENDING THE CITY OF LA FERIA COMPREHENSIVE PLAN, AND PROVIDING AN EFFECTIVE DATE

Commissioner John Betancourt moved to read the ordinance by caption only, in lieu of reading it in its entirety. Commissioner Olga H. Maldonado seconded the motion, and the motion carried by unanimous vote of the City Commissioners present. City Attorney Mr. Richard S. Talbert read the caption of Ordinance 2014-12. After reading of the ordinance, Commissioner John Betancourt moved to approve Ordinance 2014-12 amending Chapter 14, Exhibit A of the La Feria Code of Ordinance (the Zoning Ordinance), amending the boundaries of the C-1 and C-2 Zoning Districts on the official Zoning Map of the City of La Feria, amending the City of La Feria Comprehensive Plan, and providing an effective date. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

City Manager Mr. Sunny K. Philip explained that there were only two bids received (October 23, 2014) for the Water Plant Project I-3 Building Structure for the future UV disinfection system. They were as follows:

The bid amounts include the base bid and alternates. Mr. Philip said the recommendation is to award the contract to the low bidder R.P. Constructors, Inc. in the amount of \$459,000.00. Commissioner John Betancourt moved to award contract to R.P. Constructors, Inc. of New Braunfels, Texas in the amount of \$459,000.00. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

DISCUSSION WITH CITY COMMISSION TO RECEIVE INPUT REGARDING THE CITY OF LA FERIA'S CENTENNIAL CELEBRATION WHICH WILL BE CELEBRATED IN 2015

City Manager Mr. Sunny K. Philip said that the time is approaching very fast for the City's Centennial Celebration and from the very basic discussion staff had with the City Commission, some of the previous Commissioners and the current Commissioners, as well as the Event Planning Committee, the majority like the idea of having a two-day event, whether it be Friday all day or ½ day and Saturday in conjunction with the Fiesta de La Feria.

Mr. Philip said that the Planning Committee has been in existence for about 20 years and the City needs to utilize them to plan this celebration. He added that the celebration needs to have a good choice of bands that might have some notoriety, and a dinner as a fund raiser.

Commissioner Betancourt suggested:

- Tours of the Tichenor Mansion or a video tour of the mansion.
- Show some movies (Commissioner Betancourt will bring a list of movies suitable for the occasion)
- Some function at the library
- Shirts ordered for the Commission (Polo Shirts)

Commissioner Olga H. Maldonado suggested:

Coffee mugs as a fund raiser

Mayor Victor Gonzalez, Jr. suggested:

• That the City collect old pictures and maybe display them during the celebration.

City Manager Mr. Sunny K. Philip suggested:

- That men grow a beard for the Centennial
- Recognizing some of La Feria's famous people from La Feria such Tommy Lee Jones (actor) or Jim Hudson (football player)
- Contacting a woman who used to fly planes during World War II who still lives on the north side of La Feria
- Winter Texans first arrival in the Valley

Commissioner John Hernandez suggested:

 Murals depicting packing sheds and the cotton gins that were abundant in this area.
