He then declared that a quorum of the City Commission was present and called the meeting to order.

#### **PUBLIC COMMENTS**

Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

# DISCUSSION WITH CITY COMMISSION TO RECEIVE INPUT REGARDING THE CITY OF LA FERIA'S CENTENNIAL CELEBRATION WHICH WILL BE CELEBRATED IN 2015

City Manager Mr. Sunny K. Philip said that City Secretary Ms. Olga Oberwetter distributed a 3-page Centennial Celebration outline which included all the items that the City Commission had suggested in prior meetings and the items that were suggested by the Event Planning Committee. Mr. Philip reviewed the outline and said that this needs to be developed within the next 30 days or so. The planning process is to reach out to some people for interviews, but it needs to be identified in this outline. He said that La Feria has a history of some American Indians and the committee might need to reach out to them. He said that there may be more items to be added. Mr. Philip said the Event Planning Committee will be meeting on Monday, November 24, 2014 and he welcomed anyone who would want to participate. Commissioner John Betancourt said that the High School Band has gotten very good with the jazz section, and suggested that maybe it wouldn't have to be the entire band, or that various band events could be presented. Commissioner Julian Guevara, Jr. suggested that the event could recognize the veterans of La Feria. Mr. Philip said that the City has to raise the funds in order to hold some of these activities and that not all the activities identified would be done. Commissioner Betancourt suggested that someone contact the various churches to see if they have anything in their archives that they might want to share with the Event Planning

Committee. Mayor Victor Gonzalez, Jr. suggested that some of the items might be celebrated at different times throughout the year. He said the Centennial is not just the two day celebration, but a yearlong event that can be highlighted at different times of the year.

Finance Director Ms. Maria Chavero reviewed the financial reports for the month of October 2014 with the City Commission. ## CONSIDER AND TAKE ACTION DEEMED NECESSARY AS THE RESULT OF EXECUTIVE (CLOSED) SESSION DELIBERATIONS

There was no action needed as a result of the executive session deliberations.

DISCUSSION ON CONSIDERATION OF THE CREATION OF A CITY OF LA FERIA ANNEXATION COMMITTEE IN RELATION TO PROCEDURES REQUIRED FOR ANNEXATION OF PROPERTY BY THE CITY OF LA FERIA

Mayor Victor Gonzalez, Jr. explained that this item has been before the City Commission various times, and he asked that City Attorney Mr. Richard S. Talbert give the City Commission some options as to how to handle this item. Mr. Talbert said that the Home Rule cities in Texas have the right to annex areas, and the state legislature cannot limit that right, but they can limit the procedures to exercise that right. Mr. Talbert said that the matter that is raised in this request is asking that the City Commission do more than is

required by the State. The suggestion that the committee be permanent could not be handled by ordinance, but would need an amendment to the City Charter. Mr. Talbert said the policy question for the Commission would be, "Do you want to go further than the State requires?" Home Rule cities already follow all the procedures that the State requires. The consensus of the Commission was to take no action, so that this item would not have to come back to the City Commission. There was no action taken on this item.

City Manager Mr. Sunny K. Philip reported the following:

- The Drainage Project on Rabb Road is taking a little longer than anticipated. R.M. Walsdorf is going to step in and hopefully by December 15 they will be done. Mr. Philip explained the drainage project in detail and noted the different areas on the map.
- On the Water and Wastewater Systems Improvements Project, the installation of
  water meters has been completed, and the water looping project has been
  completed. The water main from the tower to the plant is being worked on at this
  time. The Alto Real project which is funded by a small grant from the
  Community Development Block Grant Program through Cameron County has
  been started. The building at the water plant to house the Ultra Violet System has
  been started. The City is advertising for sanitary sewer improvements to several
  areas, including the dome area on South Main Street. The Texas Water
  Development Board has cleared the project on the west side of town.
- Staff had a progress meeting with the Domes contractor today, and everything is doing okay. Staff had a preconstruction meeting with the Domes Technology contractor and tried to pinpoint a day for the inflation of the dome to announce to the public. None has been identified yet.

## CONSIDER AND TAKE POSSIBLE ACTION ON ATTENDANCE STATUS OF MAYOR AND/OR COMMISSIONERS

Mayor Victor Gonzalez, Jr. said that Commissioner/Mayor Pro Tem Esmeralda Lozano's mother is still in the hospital and Commissioner/Mayor Pro Tem Lozano could not attend this meeting. Commissioner John Betancourt moved to excuse Commissioner/Mayor Pro Tem Esmeralda Lozano's absence from this meeting. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commissioners present. Mayor Victor Gonzalez, Jr. also reported that Commissioner Olga H. Maldonado's City of Mercedes Commission meetings are on the first and third Tuesdays of the month, and since La Feria changes its Commission meetings in November and December to the first and third Tuesdays, it created a scheduling conflict for Commissioner Maldonado. Commissioner Julian Guevara, Jr. moved to excuse Commissioner Olga H. Maldonado's absence from this meeting. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.

## **ACTION FOR ADJOURNMENT**

There being no further business to conduct, Commissioner John Betancourt moved to adjourn the meeting. Commissioner John Hernandez seconded the motion, and the motion carried by unanimous vote of the City Commissioners present.
