

**RESOLUTION 2014-10**

**A RESOLUTION OF THE CITY OF LA FERIA, TEXAS, ELECTING A  
MAYOR PRO-TEMPORE OF THE CITY OF LA FERIA.**

**WHEREAS**, the City of La Feria is a duly incorporated Texas Municipal Corporation;  
and

**WHEREAS**, the City of La Feria is a Home Rule City with a Home Rule Charter; and

**WHEREAS**, the City of La Feria's Home Rule Charter, Section 2.09 requires the City  
Commission to elect one member of the City Commission to serve as Mayor Pro-  
Tempore to act in the Mayor's place and stead in the absence of the Mayor; and

**WHEREAS**, a City of La Feria General Election for 2014 was ordered by Resolution  
2014-05 to elect three City Commissioners, Commissioner Position 3, Commissioner  
Position 4 and Commissioner Position 5; and

**WHEREAS**, the newly elected commissioners have assumed their positions on the City  
Commission after filing the appropriate Statement of Elected Official and being duly  
sworn in; and

**WHEREAS**, the City Commission must elect one member of the City Commission to  
serve as Mayor Pro-Tempore in the absence of the Mayor; and


**WHEREAS**, Commissioner Olga Hinojosa Maldonado nominated Commissioner  
Esmeralda Lozano to be elected as Mayor Pro-Tempore, which nomination was  
seconded by Commissioner John Hernandez; and,

**WHEREAS**, Commissioner Esmeralda Lozano accepted the nomination to serve as  
Mayor Pro-Tempore,

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF  
THE CITY OF LA FERIA, TEXAS, THAT COMMISSIONER ESMERALDA  
LOZANO HAS BEEN ELECTED AS MAYOR PRO-TEMPORE OF THE CITY  
OF LA FERIA, TEXAS, TO ACT IN THE MAYOR'S PLACE AND STEAD IN  
THE ABSENCE OF THE MAYOR UNTIL SUCH TIME AS A NEW MAYOR  
PRO-TEMPORE IS ELECTED.**
