REVIEW AND APPROVE MINUTES OF PROCEEDINGS OF THE PREVIOUS REGULAR MEETING OF THE LA FERIA INDUSTRIAL DEVELOPMENT CORPORATION (LFIDC) HELD ON THURSDAY, MARCH 5, 2015

After review of the minutes, Ms. Candace Guillen moved to approve the minutes of proceedings of the previous regular meeting of the La Feria Industrial Development Corporation (LFIDC) held on Thursday, March 5, 2015. Mr. Lloyd Betts seconded the motion, and the motion carried by unanimous vote of the LFIDC board members present.

CONSIDER AND TAKE ACTION TO ACCEPT THE ANNUAL AUDIT REPORT FOR THE LA FERIA INDUSTRIAL DEVELOPMENT CORPORATION (LFIDC) FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2014

Mr. Quentin Anderson and Mr. Robert Rodriguez of the accounting firm of Long Chilton, LLP were present at the meeting to present and review the LFIDC Annual Audit Report for the fiscal year ending September 30, 2014 with the LFIDC Board. Mr. Anderson referred the board members to pages 4 and 5 which is the Independent Auditors' Report which stated, "In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the business-type activities of La Feria Industrial Development Corporation as of September 30, 2014 and 2013, and the changes in its financial position, and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America." Mr. Anderson noted that the Management's Discussion & Analysis starting on page 7 through 11 presents an overview of the LFIDC's financial position, and compares the last three years' activities. Mr. Anderson then reviewed the financial statements in detail. After review and all questions answered, Mr. Ignacio A. Garcia Galvez moved to accept the Annual Audit Report for the La Feria Industrial Development Corporation (LFIDC) for the fiscal year ending September 30, 2014. Mr. Lloyd Betts seconded the motion, and the motion carried by unanimous vote of the board members present.

MONTHLY FINANCIAL REPORTS FOR THE MONTH OF MARCH 2015

Finance Director Ms. Maria Chavero reviewed the monthly financial reports for the month of March 2015 with the board. She reviewed the Budget vs. Actual Report comparing revenues and expenditures for the month and the year-to date figures as well. Ms. Chavero then reviewed the Analysis of Current IDC Sales Tax Collection report which reflected a monthly average sales tax collection of \$24,720. She also reviewed the Comptroller's Report which showed that the year-to-date sales tax is 9.31% over last year's. After review the financial reports were filed for audit.

Mr. Lloyd Betts seconded the motion, and the motion carried by unanimous vote of the board members present.
- 2. Mr. Lloyd Betts moved to authorize City Manager/Executive Director Mr. Sunny K. Philip to continue negotiations with ACME Sign Co. for the lease of the property to install an electronic sign and to execute all documents in accordance with the terms discussed in executive session. Mr. Ignacio A. Garcia Galvez seconded the motion, and the motion carried by unanimous vote of the board members present.
