A RESOLUTION OF THE CITY OF LA FERIA, TEXAS, DESIGNATING AUTHORIZED SIGNATORIES FOR CONTRACTUAL DOCUMENTS AND DOCUMENTS FOR REQUESTING FUNDS PERTAINING TO THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT (TxCDBG) – TEXAS CAPITAL FUND (TCF) INFRASTRUCTURE DEVELOPMENT PROGRAM IN SUPPORT OF CARDENAS BMW.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LA FERIA, TEXAS, AS FOLLOWS:

SECTION 1. The City Manager be authorized to execute contractual documents between the Texas Department of Agriculture and the City for the 2014 Texas Community Development Block Grant – Texas Capital Fund program.

SECTION 2. The City Manager, City Secretary, Finance Director, and the Planning and Community Development Director be authorized to execute the *State of Texas Purchase Voucher and Request for Payment Form* (Form A203) document required for requesting funds approved in the 2014 Texas Community Development Block Grant – Texas Capital Fund Program.
