Mr. Ricardo J. Navarro addressed the Commission in regards to providing special counsel legal services for the City Commission and the Interim City Manager. The Commission previously retained Denton, Navarro, Rocha, Bernal, Hyde & Zech PC to assist as special counsel in connection with City Manager employment status under the charter. Continuation of the same terms will allow the firm to provide legal advice until a permanent city manager is selected. The City Attorney position is currently vacant and may be filled upon selection of a permanent city manager utilizing the request for qualification process. Mr. Navarro indicated that they will be present at the meetings if needed, and will follow up with Ms. Sanchez to discuss any pending

legal matters.

### PRESENTATION AND DISCUSSION OF DELINQUENT TAX REPORT BY PERDUE, BRANDON, FIELDER, COLINS & MOTT, LLP.

Mr. Hiram Gutierrez reviewed the City of La Feria delinquent tax report for fiscal year 2016-2017 with the Commission. A copy of the report was presented to the Commission. The delinquent tax roll was approximately \$193,000 at the end of June. Approximately \$50,930 of this amount is in deferrals, including accounts of property owners over age 65 or with a disability, accounting for 26% of the delinquent tax roll. This amount cannot be actively collected. Additionally there is \$21,000 in litigation, \$7,400 in bankruptcy, and \$105,000 currently being collected through phone calls, mailings, and personal visits. A total of \$65,468 in base tax, penalties, and interest has been collected.

Mr. Gutierrez stated that they had taken over the account recently and many of the accounts were not coded correctly so they are reviewing accounts to address each one is coded appropriately. Mr. Gutierrez clarified two issues on the report. First, that those who are in deferral status may eventually pay the taxes and second that the uncollectible delinquent taxes are usually businesses that no longer exist and without assets to go after. There are still about 440 delinquent accounts that need to be collected. Mr. Gutierrez further discussed the process of working with those who may need to file for deferral status. The process requires an application to the County with required proof of their status if for example they may be disabled. The current collection percentage for La Feria is about 20%. Commissioner Hoff raised concerns about the low number. Mr. Gutierrez explained that there are many accounts yet to be collected and with a high deferral rate, it is difficult to show greater collection percentages. Mr. Gutierrez will present comparable information as requested for the next report. Mayor Pro-Tem Lozano raised concern about the firm's outreach efforts. Mr. Gutierrez discussed the possibility of tax clinics to inform and assist residents with their delinquent taxes to provide them information about the options available to them including deadlines, and setting up a workshop in conjunction with staff from the Appraisal District. Mr. Gutierrez will follow up with administration to provide information such as frequently asked questions on the city website and possibly include a link to information provided by Perdue, Brandon, Fielder, Colins & Mott, LLP. Additional detailed information of the delinquent tax roll can be provided on a quarterly report if the Commission wants to review the details. The benefit of such a report provides the Commission an opportunity to determine what is going on in the community and the option to provide updated information to the attorneys in a workshop setting. Mr. Quintanilla added that the firm is prepared to move forward with the outreach efforts and pointed out that the firm already utilizes home visits to facilitate collection efforts. If the Commission is aware of anyone that may benefit from a home visit, they should notify the firm so a follow up with the property owner may be scheduled.

# REVIEW TABULATION OF PROPOSALS RECEIVED, CONSIDER, AND TAKE ACTION TO AWARD A CONTRACT FOR THE CITY OF LA FERIA EMPLOYEE GROUP HEALTH INSURANCE AND DESIGNATE AN AGENT FOR THE CITY OF LA FERIA.

Copies of the group health insurance proposals received in response to the Request for Proposals were presented to the Commission. Proposals were received from Allegian, Employee Group Health Benefits, TML, and Gallagher Benefits. Ms. Sánchez reviewed the bid tabulations. Gallagher did not include the proposal bid sheets in the submission. Since the RFP did not include language about disqualification, all submissions were accepted; the numerous plan options presented by Gallagher were reviewed by staff and several options closest to the current plan were included in the bid tabulation. The City currently pays \$305.29 in monthly premiums per employee. The rates presented by the respondents were identified on the bid tabulation and reviewed with the Commission.

The documentation presented to the Commission identified the most comparable plan available and the best rate was offered by Allegian. An alternate to the current plan was presented for consideration in preparing the budget. The alternate plan offers the same benefits with a \$500 increase in individual deductible and \$1,000 increase per family deductible. This plan costs the City approximately \$12,000 less than the renewal plan. Discussion followed about the City's options and costs per employee relative to next year's budget.

Mayor Pro-Tem Lozano discussed the possibility of cost sharing with employees and the impact that may have on the budget. She informed the Commission of the research she did by contacting ten communities similar to La Feria and gathering information on their policy in providing employee health insurance. Current Allegian agent, Ms. Joanie Bianchini, discussed the cost per employee, the changes in the health insurance industry, and the impact on insurance fees. Ms. Bianchini discussed the new regulations regarding cost share programs and the impact it has on companies. Discussion followed about the benefit of paying insurance for employees at 100% versus cost sharing in the next fiscal year. According to Ms. Bianchini, the City's employees have a high utilization rate, indicating the employees truly use this benefit. Cost sharing may be an option in the future, but it was not recommended for the 2016-2017 fiscal year. At the Commission's request, staff will review the budget to identify any cost saving opportunities in the budget and present various cost sharing options to present at the next meeting.

The business owners were present and confirmed they are in compliance with the requirements for this type of business and the regulatory agency will continue to monitor them for compliance. Mayor Pro-Tem Lozano asked the resident present if they had any comments. Marlene Peavler, a resident of the area under consideration, stated she is in favor of the business.

The drainage project north of La Feria should be completed within forty-five days. Texas Cordia is near completion of the railroad crossing.

Texas Cordia is remobilizing to finish the paving and clean up of Kelly Drive and Beddoes Road.

The crossing at the Arroyo and at White Ranch Road continues and will require execution of a change order. There will be a meeting later in the week to discuss finalizing the project.

Mor-Wil Construction is coordinating with TXDOT on the drainage improvements along north Beddoes Road. TXDOT has allowed us to tie in to their outfall.

The La Feria Irrigation District has forced the contractors to stop working on the project off Rabb Road and south of Business 83. They stated permits were required and fees are due to continue the project because we are crossing their lines. Mr. Alfonso Gonzalez of SWG Engineering spoke to the Irrigation District Board during the design phase of this project and indicated it would be completed in phases. Ms. Sánchez said they will speak to the land owners and then to the Irrigation District to resolve this matter, since it appears the line in question may

be a private line and may be abandoned.

The Safe Rooms (Domes) are finished. The pending items include close out documentation and approval from the State. The funding agency is interested in attending the grand opening when scheduled.
