PUBLIC COMMENTS

Mayor Gonzalez opened the public comments session. Ms. Delores Fuller of 1000 S. Chelo Drive, La Feria, Texas addressed the Commission regarding the following: La Feria News published an article about adding new police officers, but in reality they just replaced officers who left the force; she also stated that the restrooms at Tiny Town Park were dirty and people may be at risk of infection. Ms. Fuller further stated that grants for the parks are not free and that the City must keep up the facilites, specifically discussing the sinks at the Nature Park. Ms. Fuller stated she visits the parks regularly and states that they do not smell clean. Ms. Fuller stated she is going to continue to work to keep the people informed. Mayor Gonzalez asked her to call him the following day to discuss her concerns further.

Christina Dalum of 1101 Colt, La Feria also addressed the Commission. She shared concerns over the maltreatment of pets, indicating she has noticed neglect and wants to know what the City can do about enforcing residents take care of their animals. She would like to see people providing proper care and food for their pets. Ms. Dalum asked if ther was an orndinace prohibiting residents

from restraining their animals 24 hours a day since animals can get aggressive. She asked the Commission to consider enacting an Ordinance if one does not exist to protect pets in the Community.

CONSIDER AND TAKE ACTION TO APPROVE THE FINAL PLAT OF THE TRES ROBLES SUBDIVISION

Mr. Phlip infored the Commission that the Planning & Zoning Commission met on Monday, February 8, 2016 to review the final plat of the Tres Robles Subdivision and recommended approval of the final plat, as it meets requirements of the model subdividsion rules. Dustin Moore, Engineer and Developer of the property was present at the City Commission meeting to answer questions during the discussion. Mayor Gonzalez inquired about the City's sidewalk ordinance asking if we can require such along the length of the property since all entrances will be accessible from Kansas City Road. During the discussion a decision was made to include a hand written note in the plat requiring sidewalks with the issuance of the building permit. Mr. Moore will include such note with language for the property buyer to install the sidewall. A handwritten note will be enforecable. Following discussion, a motion was made, seconded, and approved as noted for the approval of the final plat of the Tres Robles Subdivision with the inclusion of a handwritten note for the sidewalks as discussed.

PUBLIC HEARING TO RECEIVE INPUT FROM THE PUBLIC REGARDING A REQUEST BY THE LA FERIA INDUSTRIAL DEVELOPMENT CORPORATION FOR A SPECIFIC USE PERMIT FOR ALCOHOL SALES RELATED TO THE FIESTA DE LA FERIA CELEBRATION WHICH WILL BE HELD ON FEBRUARY 27, 2016

Mayor Gonzalez declared the public hearing open. Mr. Philip explained the history of the specific use permit for alcohol sales at the Fiesta de La Feria. The request made by the LFIDC is the same as in previous years for this event. No individual from the audience offered comments. Upon review by Mr. Talbert, an item was added to include language regarding the prohibition of concealed and open carry handguns pursuant to sections 30.06 and 30.07 of the Penal Code. A copy of the revised SUP was distributed to the Commission for review. Following review and discussion, a motion was made, seconded, and approved as noted to approve the LFIDC's request for a specific use permit for alcohol sales at the Fiesta de La Feria scheduled for February 27, 2016.

CONSIDER AND TAKE ACTION TO APPROVE A RESOLUTION AUTHORIZING THE TEXAS COALITION FOR AFFORDABLE POWER, INC (TCAP) TO NEGOTIATE AN ELECTRIC SUPPLY AGREEMENT FOR FIVE YEARS EFFECTIVE JANUARY 1, 2018, AUTHORIZING TCAP TO TO ACT AS AN AGENT ON BEHALF OF THE CITY TO ENTER INTO A CONTRACT FOR ELECTRICITY, AUTHORIZING THE CITY MANAGER TO EXECUTE AN ELECTRIC SUPPLY AGREEMENT FOR DELIVERIES OF ELECTRICITY EFFECTIVE JANUARY 1, 2018 AND COMMITTING TO BUDGET FOR ENERGY PURCHASES IN 2018 THROUGH 2022 AND TO HONOR CITY'S COMMITMENTS TO PURCHASE POWER FOR ITS ELECTRICAL NEEDS IN 2018 THROUGH 2022 THROUGH TCAP

Mr. Philip discussed the approval of a similar resolution in a previous meeting. Since that meeting, Texas Coalition for Affordable Power (TCAP) later visited and explained that waiting until March 2016 was a better option that may bring greater savings. A copy of the resolution was provided for review. Mr. Talbert noted a change to Section 3 of page 3 adding Mayor Victor Gonzalez and City Secretary Esmeralda Sanchez also be authorized to sign the contract. Mr. Philp requests the City select Contract Option 1-fixed-price, full requirements at a price not to exceed 4.1 cents per kWh for the North and West zones or 4.25 cents per kWh for the South and Houston zones. Following discussion a motion and seconded to read the caption of Resolution 2016-07.

READ THE CAPTION OF RESOLUTION 2016-07

The motion to read the caption of Resolution 2016-07 passed as noted authorizing the Texas Coalition for Affordable Power, Inc. (TCAP) to negotiate an electric supply for five years effective January 1, 2018, authorizing TCAP to act as an agent on behalf of the City to enter into a contract for electricity, authorizing the City Manager to execute an electric supply agreement for deliveries of electricity effective January 1, 2018 and committing to budget for energy purchases in 2018 through 2022 and to honor the City's commitments to purchase power for its electrical needs in 2018 through 2022 through TCAP.

Mr. Talbert then proceeded to read the caption of Resolution 2016-07.

Mr. Philip reported on the projects identified as follows: The drainage improvement projects are moving along. A memo was distributed regarding a tour of the project sites scheduled for February 20 from 9an to noon. Texas Division of Emergency Management provides HMGP funding for some of the drainage projects. Staff contacted the City regarding additional funds available to further assist the City for the Levee Crossing and Rabb Road projects. Funds are only available for construction costs. The Water and Wastewater Systems Improvements Project are also moving forward. The tour of these project sites is scheduled for Saturday, February 13th from 9 am to noon. The safe rooms are still under construction and will require an extension from the state. The Fire Station expansion and substation is moving along, although there was an issue with the original foundation it has since been removed and the new foundation has passed inspection. The

Technology and Success Center is expected to be complete by June 30th as expected. Planning for the Fiesta de La Feria continues, there are no major changes, people are enthused about the music line-up.

Commissioner Hernandez inquired about the fire department's truck with the flat tires parked in the driveway. Mr. Philip informed the Commission that the tires self inflate when the truck is turned on.

Mayor Gonzalez then declared no action was required as a result of the reports.
