Mayor Victor Gonzalez, Jr. declared the public hearing open at 6:43 P.M. There were no comments from the audience, so Mayor Victor Gonzalez, Jr. declared the public hearing closed at 6:43 P.M.

# CONSIDER AND TAKE ACTION TO APPROVE OR DENY AN ORDINANCE OF THE CITY OF LA FERIA, TEXAS AMENDING CHAPTER 14, EXHIBIT A OF THE LA FERIA CODE OF ORDINANCES (THE ZONING ORDINANCE), AMENDING THE BOUNDARIES OF THE C-2 ZONING DISTRICT ON THE OFFICIAL ZONING MAP OF THE CITY OF LA FERIA, AMENDING THE CITY OF LA FERIA COMPREHENSIVE PLAN, AND PROVIDING AN EFFECTIVE DATE

Commissioner Julian Guevara, Jr. moved to table this item due to the fact that the Planning and Zoning Commission was not able to meet for lack of quorum. Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commission. This item will come back before the City Commission once the Planning and Zoning Commission meets.

REVIEW PROPOSALS RECEIVED AND SELECT THE MOST QUALIFIED FIRM(S) AND AUTHORIZE THE CITY MANAGER TO NEGOTIATE AND EXECUTE THE CONTRACT(S) FOR PLANNING SERVICES IN THE DEVELOPMENT OF THE CITY OF LA FERIA COMPREHENSIVE MASTER PLAN FUNDED BY THE TEXAS DEPARTMENT OF AGRICULTURE, TXCDBG PLANNING AND CAPACITY BUILDING FUND; MULTI-HAZARD MITIGATION ACTION PLAN FUNDED BY THE FEDERAL EMERGENCY MANAGEMENT AGENCY THROUGH THE TEXAS DIVISION OF EMERGENCY MANAGEMENT; AND A COMPREHENSIVE STRATEGIC PLAN FOR TARGETED AREAS PRIMARILY WITH THE CITY OF LA FERIA ETJ, IF FUNDED BY USDA RURAL BUSINESS SERVICE, RURAL BUSINESS ENTERPRISE GRANT

Commissioner Esmeralda Lozano moved to go into executive session to consult with the City Attorney before consideration of this item. Commissioner John Betancourt seconded the motion, and the motion carried by unanimous vote of the City Commission. The executive session scheduled as an addendum to the agenda was also read and was considered at the same time. Mayor Victor Gonzalez, Jr. declared the meeting in executive session at 6:44 P.M. After executive session deliberations, Mayor Victor Gonzalez, Jr. declared the meeting back in open session at 7:47 P.M.

After executive session, Mayor Victor Gonzalez, Jr. announced that they would consider item number nine next. City Manager Mr. Sunny K. Philip provided the current two-volume Comprehensive Plan to the City Commission and explained that right after the Plan was developed, the City applied for a \$25 million grant from the Texas Water Development Board for Water and Sewer Improvements and received \$15 million. The City also applied for a grant for drainage improvements in the amount of \$22 million and received about \$18 million. Mr. Philip said that the Comprehensive Plan is usually developed for a 20 year period and it takes about seven (7) years for the City to accomplish most of it. It is time to revamp the Plan. The City applied for grant funds from the Texas Department of Agriculture for planning funds and they approved a grant in the amount of \$55,000 with a City match of \$11,000. Mr. Philip added that the Hazard Mitigation Plan was developed some years ago, and because of that, the City was able to do the Rabb Road Improvements. Currently the Hazard Mitigation Action Plan is expired, so the City applied for funds from the Texas Division of Emergency Management for the development of a Hazard Mitigation Action Plan and received an award in the amount of \$50,000 with a local in-kind match of \$16,667. The City also applied for grant funds from USDA for the development of a Comprehensive Strategic Plan for targeted areas primarily within the City of La Feria ETJ, and they have not made a decision yet. Mr. Philip discussed the importance of having a quality plan when it comes to applying for grant funds and how the Comprehensive Plan and the Hazard Mitigation Action Plan played a role in the City's successful funding of grants from the Texas Water Development Board and the General Land Office.

Commissioner John Betancourt left the meeting at this point at 8:00 P.M.

City Manager Mr. Sunny K. Philip reviewed the scoring Matrix for the Hazard Mitigation Action Plan and the Comprehensive Plan scored by Planning and Community Development Director Ms. Paula Rodriguez, Capital Projects Coordinator Ms. Esmeralda Sanchez, and Mr. Philip. City Manager Mr. Sunny K. Philip reported on the following:

- Drainage Improvements Nothing new to add on the drainage project.
- Water and Wastewater Systems Improvements The City Commission awarded the contract earlier on two items; one was on sewer improvements on east side and the other one was the water line extension all the way to Rabb Road from the JoEtt area. The contractor should be starting on the week of the 27<sup>th</sup>. The dome facility on South Main does not have sewer service and this project will bring that service to the dome. One other major project needs to be advertised and that will be advertised next Friday with a bid Opening of August 4, 2015. That will come before the City Commission on August 11, 2015. And that project will be building two lift stations. One west of Rabb Road on the south side of Business 83 and the other one between the Expressway and Business 83 on Kubiski Road. That will serve all the area that they City has annexed.
- The Safe Rooms Progress has slowed down a bit. The construction time has to be extended due to various reasons.
- Ground Breaking Ceremony for Unger Park There was a pre-construction meeting last
  week on the Unger Park, and the Ground Breaking Ceremony will be held on August 4,
  2015 at 10:00 A.M. Invitations will go out on Monday, July 20, 2015, and the staff will
  hand deliver invitations to the neighborhood around the park area. Mayor Victor
  Gonzalez, Jr. and Commissioner Esmeralda Lozano said they would like to participate in
  delivering the invitations to the neighborhood.
