REPORTS BY STAFF

WATER AND WASTE WATER IMPROVEMENTS

Mr. Philip reported the following:

Cornett Consruction is completing the last of the water line installations on the west side. The next phase of the project involves testing. Pending water related contracts include Motor Control Center at the Water Treatment Plant. This work should leave enough funds to hook up customers via a change order to an existing contract.

Saenz Brothers Construction is moving along on the sewer system improvements. The ground water has kept them busy in some areas. They will be moving on to the Main Street area in about another month.

The contract awarded to JM Construction is pending TWDB approval for execution.

The TWDB visited the project sites on Wednesday January 6th. They also visited the nature park and we drove them through the colonia areas benefiting from their funds. They were please to see our projects under constrution and to see the improvement to the residents in the areas impacted by the projects.

Construction of the new office at the Water Treatment Plant should begin next week.

Mayor Gonzalez inquired about an overlay for Memorial Street. That road improvement is not part of the water/wastewater projects, but there will be bond money available for such improvements.

Mr. Loped declared that no official action was required as a result of these reports.
