PUBLIC COMMENTS

REVIEW AND TAKE ACTION TO APPROVE MINUTES OF PROCEEDINGS OF THE REGULAR MEETING OF THE LA FERIA UTILITIES BOARD HELD ON TUESDAY JUNE 14, 2016.

• WATER AND WASTE WATER IMPROVEMENTS

Mr. Philip reported the following:

A letter to the TWDB has been sent regarding the hookups for the West Colonias, a project by Cornett Construction. The City is pending approval from the TWDB legal department for these hook ups.

Saenz Brothers has completed work on sewer lines on South Main, and part of Parker Road. They are still waiting on the Lift Station to be completed before service can be established.

JM Construction had a late start on the sewer lines for the West Colonias due to the rain and delay of materials. They are currently installing the wetwell south of Business 83, west of Rabb Road.

Phase II of the Sanitary Sewer Improvements for West Colonias is pending TWDB approval to begin constructionn.

JCON Construction has poured the foundation for the Water Treatment Plant Office. The foundation must be able to withstand extreme weather. They have slowed down on the project, bu the City is putting pressure on them to keep moving.

The Board inquired about the use of the building and SCADA. Discussion followed regarding the SCADA System, its cost effectiveness and the existing items that can be utilized with the new system.

There being no further discussion, Mr. Lopez declared that no official action was required as a result of these reports.

There being no further business to conduct, Ms. Dunlap made a motion to adjourn the meeting. Mr. Muse seconded the motion, and the motion carried by unanimous vote of the Board Members present.
