# 8. STATUS UPDATE ON FINANCIAL AUDIT FOR FISCAL YEAR ENDING SEPTEMBER 30, 2016.

In response to a question from Mayor Pro-Tem Hoff, Mr. Anderson stated that he could not say where any "missing money" was until the audit was complete. Mr. Sandoval said that the completed audit will be presented at the next City Commission meeting. There was no action taken on this item.
