# 7 CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2017-32 TO AWARD A CONTRACT TO THE LOWEST RESPONSIVE, RESPONSIBLE BIDDER FOR THE CONSTRUCTION OF TWO (2) HOMES IN LA FERIA THROUGH THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS HOME PROGRAM

Bids were opened on November 17, 2017 for the construction of two new homes to be located at 304 Villarreal Street and 400 W. Primrose Street. The property owner at 304 Villarreal Street has received a grant through the Texas Department of Housing and Community Affairs HOME Program for construction of the home. The property owner at 400 W. Primrose is pending grant funding from Texas Department of Housing and Community Affairs. Four bids were received and the low bid amount met TDHCA program requirements for the cost of construction. The lowest, responsive, responsible bidder is RG Enterprises. Commissioner Guevara made a motion to approve Resolution 2017-32 to award a contract RG Enterprises for the construction of two (2) homes in La Feria Through the Texas Department of Housing and Community Affairs HOME Program. The motion was seconded by Mayor Pro-Tem Hoff and passed unanimously.
