

RESOLUTION 2017-01

A RESOLUTION OF THE CITY OF LA FERIA, TEXAS, APPOINTING A REPRESENTATIVE AND ALTERNATE REPRESENTATIVE TO THE REGIONAL TASK FORCE, AND AUTHORIZING REPRESENTATIVE(S) TO IMPLEMENT AN INTERLOCAL AGREEMENT WITH THE UNIVERSITY OF TEXAS RIO GRANDE VALLEY, AND AUTHORIZING TO MANAGE TASKS AUTHORIZED BY SAID INTERLOCAL AGREEMENT ON BEHALF OF THE CITY OF LA FERIA, TASK FORCE IS FORMED TO RESPOND AND AID COMPLIANCE WITH THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY PHASE II STORM WATER RULES

WHEREAS, the City Commission of the City of La Feria has heretofore determined to enter into an Intelocal Cooperative Agreement with the University of Texas Rio Grande Valley (UTRGV) as a manner by which the City can actively participate in a Regional Task Force formed to respond and aid compliance with the Texas Commission on Environmental Quality Phase II Stormwater Rules; and

WHEREAS, the City desires to accomplish the goals of responding and complying with the Rules through the formation of a Regional Task Force, established and managed by UTRGV; and

WHEREAS, the City will appoint one (1) representative and one (1) alternate representative to the task force, to act as the Liason(s) between the City and the Task Force, apprising each entity of each other's objectives; and

WHEREAS, UTRGV will formulate and propose to the Task Force methods and approaches for compliance with the Texas Commission on Environmental Quality Phase II Stormwater Rules, including speculative cost analysis and budget projections; and

WHEREAS, UTRGV will provide research, educational services, and technical support to the Task Force for any adopted methods and approaches for compliance.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LA FERIA, TEXAS:

PART I. That it is hereby determined to enter into an Interlocal Cooperative Agreement with the University of Texas Rio Grande Valley (UTRGV), as a manner by which the City can actively participate in a Regional Task Force formed to respond and aid compliance with the Texas Commission on Environmental Quality Phase II Stormwater Rules.


PART II. That Paula M. Rodriguez, Planning and Community Development Director and Jaime S. Sandoval, City Manager are hereby appointed as Representative and Alternate Representative, respectively, to the Regional Task Force, and are hereby authorized and directed to act as Liaison between the City and the Task Force, subject to the bylaws, policies, rules and procedures of the Task Force, as described in the Interlocal

Agreement for Representative Appointment to Regional Task Force, attached hereto and incorporated herein for purposes as Exhibit "A".


PART III. That this resolution shall take effect immediately after its passage.
