WHEREAS, the City Commission is the governing body that appoints the Board of Directors for the LFEDC,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LA FERIA, TEXAS, THAT MAYOR OLGA H. MALDONADO AND GUEVARA, RE-APPOINTED AND COMMISSIONER JULIAN JR. BE **ERIC** HOFF, COMMISSIONER **DONATO** GARCIA, COMMISSIONER FRANCISCO LOYA, JR AND JOSE R. BECERRA JR. BE APPOINTED TO SERVE ON THE LA FERIA ECONOMIC DEVELOPMENT CORPORATION; AND THAT THE FOLLOWING ARE THE NAMES AND TERMS OF THE LA FERIA ECONOMIC DEVELOPMENT CORPORATION BOARD OF DIRECTORS:
