

#### Basic Requirements to Open a Business in La Feria

- 1. Locate in a commercial zoning district. These zoning districts include: C-1 (Restricted Commercial), C-2 (General Commercial), L-C (Light Commercial), and I (Industrial).
  - Alternatively, operation of a "home occupation" is permissible in a residential district if a Specific Use Permit is granted by the City Commission. The SUP application fee is \$150 and requires three to four weeks to process.
- 2. Apply for a Certificate of Occupancy Inspection \$35 inspection fee. Please submit a site plan with this application, showing, at a minimum, lot lines, parking spaces, driveways, and building entrance. The building inspector and fire marshal must inspect the premises and approve it for the proposed use.
  - Minimum requirements include: handicapped accessible parking, an accessible route from the parking to the front door, and an accessible entrance. If alterations are made to the interior of the structure, a handicapped accessible restroom is also required. Minimum fire code requirements include: emergency exit lights, fire extinguishers, and adequate egress. Other requirements may apply.
- 3. Obtain a City of La Feria business license one time fee of \$10.00 for most types of businesses. Other license fees apply to certain types of businesses including those selling alcohol.
- 4. Open water, wastewater and solid waste accounts with the City \$100 deposit plus \$20 account initiation fee.

Monthly charges will depend on the amount of water used and trash generated. The minimum monthly charge for up to 3,000 gallons of water per month and one 300 gallon trash receptacle picked-up once weekly is \$59.50 per month (including a \$2/month emergency services fee).

### Additional Rules Applicable to Food Establishments

- 1. Must adhere to State of Texas Food Establishment Rules, which are published by the Texas Department of Health Services and are available on that agency's website: <a href="http://www.dshs.state.tx.us/foodestablishments/">http://www.dshs.state.tx.us/foodestablishments/</a>
- 2. Must obtain a Cameron County Health Permit. That department can be reached at 956-247-3599. The permit application and an informational packet can be picked up from the County Office in San Benito.
- 3. Food establishments must have a grease interceptor installed on the sanitary sewer line.
