**5. CITY ANNOUNCEMENTS AND EVENTS**

**A. PRESENTATION OF DONATION CHECK TO THE CITY OF LA FERIA FROM THE ANTIQUE AUTOMOBILE CLUB OF AMERICA FOR THE RGV FOOD BANK – LA FERIA BRANCH COLLECTED FROM THE FIESTA DE LA FERIA CAR SHOW.**

Moses Mendoza, President of the Antique Automobile Club of America thanked the Mayor and Commissioners for their support of the annual car show. He informed the Commission that the car show had garnered \$691 and several boxes full of canned goods to be donated to RGV Food Bank of La Feria. He also presented the Mayor and Commission a plaque thanking the City for their support of the Car Show. There was no action taken on this item.

**B. APPROVAL OF MINUTES FOR CITY COMMISSION MEETING HELD FEBRUARY 12, 2019.**

7. **CONSIDERATION AND POSSIBLE ACTION TO ENTER INTO A CONTRACT FOR PROFESSIONAL SERVICES WITH R. GUTIERREZ ENGINEERING CORPORATION.**

Commissioner Guevara made a motion to enter into a contract for professional service with R. Gutierrez Engineering Corporation. The motion was seconded by Commissioner Garcia and passed unanimously.

8. **CONSIDERATION AND POSSIBLE ACTION TO APPROVE A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF LA FERIA AND RATES RGV FOR PREPARATION OF A REGIONAL STORMWATER PERMIT APPLICATION AND STORMWATER PLAN FOR THE LOWER RIO GRANDE VALLEY TPDES STORMWATER TASK FORCE.**

Mr. Sandoval explained that the Cities participation in the Taskforce requires a six thousand dollar contribution. Commissioner Lozano made a motion to approve a memorandum of understanding between the City of La Feria and RATES RGV for preparation of a regional Stormwater permit application and Stormwater Plan for the Lower Rio Grande Valley TPDES Stormwater Task Force. The motion was seconded by Commissioner Guevara and passed unanimously.

9. **CONSIDERATION AND POSSIBLE ACTION ON AGREEMENT TO DONATE OFFICE SPACE AT 126 E. COMMERCIAL AVE. TO SERVE AS THE DISTRICT OFFICE FOR STATE REPRESENTATIVE OSCAR LONGORIA.**

Commissioner Lozano made a motion to approve an agreement to donate office space at 126 E. Commercial Ave. to serve as the District Office for State Representative Oscar Longoria. The motion was seconded by Mayor Pro-Tem Zuniga and passed unanimously.

10. **ADJOURN.**


