Mayor Maldonado announced that the City was hosting a Spring Fair on March 23 at the recreation center. There will be free health screenings, raffles, and vendors.

6. CONSENT AGENDA:

A. APPROVAL OF MINUTES FOR CITY COMMISSION MEETING HELD FEBRUARY 26, 2019.

Commissioner Guevara made a motion to approve the items under consent agenda as presented. The motion was seconded by Commissioner Garcia and passed unanimously.

7. <u>DISCUSSION AND CONSIDERATION OF CONTRACT AMENDMENTS</u>
WITH SWG ENGINEERING LLC FOR THE TWDB WATER PROJECT
"WATER IMPROVEMENTS FOR THE CITY OF LA FERIA AND TWDB

CLEAN WATER PROJECT "WASTEWATER IMPROVEMENTS FOR THE CITY OF LA FERIA"

Mr. Sandoval explained that the Texas Water Development Board water and wastewater projects had been completed under budget. The City now has the opportunity to use the additional funds on further water or wastewater projects. Commissioner Lozano made a motion to approve a contract amendment with SWG Engineering LLC for the TWDB water project Water Improvements for the City of La Feria" and TWDB "Clean Water Improvements for the City of La Feria". The motion was seconded by commissioner Martinez and passed unanimously.

8. <u>DISCUSSION AND CONSIDERATION OF THE PROJECTS FOR THE TWDB WATER PROJECT AND TWDB CLEAN WATER PROJECT.</u>

Randy Winston of SWG Engineering LLC presented possible projects for the TWDB funds discussed in the previous item. There are several options for funding at both the water and wastewater treatment facilities. There was no action taken on this item.
