4. PUBLIC COMMENTS

There were no comments from the public.

5. CONSENT AGENDA:

- a. APPROVAL OF MINUTES FOR CITY COMMISSION MEETINGS HELD MARCH 28, 2023.
- b. APPROVAL OF QUARTERLY INVESTMENT REPORT.

Mayor Pro-Tem Guevara made a motion to approve the items under consent agenda as presented. The motion was seconded by Commissioner Garcia and passed unanimously.

6. PUBLIC HEARING ON ZONE CHANGE REQUEST FROM R-1 SINGLE FAMILY RESIDENTIAL DISTRICT TO R-3 SINGLE FAMILY RESIDENTIAL DISTRICT TO ALLOW FOR DUPLEX CONSTRUCTION ON LOTS 36 TO 47 MAIN STREET SUBDIVISION.

Mayor Maldonado opened the public hearing at 6:31 pm. Mr. Ortiz explained that the request was previously approved by the Planning & Zoning Board. He also noted that there were no comments received in response to letters sent to surrounding homeowners. There were no additional comments from the public and the hearing was closed at 6:33 pm.

7. CONSIDERATION AND POSSIBLE ACTION ON ZONE CHANGE REQUEST FROM R-1 SINGLE FAMILY RESIDENTIAL DISTRICT TO R-3 SINGLE FAMILY RESIDENTIAL DISTRICT TO ALLOW FOR DUPLEX CONSTRUCTION ON

LOTS 36 TO 47 MAIN STREET SUBDIVISION.

Mayor Pro-tem Guevara made a motion to table the zone change request from R-1 Single Family residential district to R-3 Single family residential district to allow for duplex construction on Lots 36 to 47 Main Street Subdivision.

8. CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2023-10 ENDORSING AND SUPPORTING THE SOUTH TEXAS INTERNATIONAL MARATHON.

Mr. Sandoval explained that the marathon route would begin in Donna and continue along Business 83 before ending in Harlingen. Commissioner Garcia made a motion to approve Resolution 2023-10 endorsing and supporting the South Texas International Marathon. The motion was seconded by Commissioner Martinez and passed unanimously.

9. <u>CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2023-11</u> SUPPORTING ARTIFICIAL DRAINAGE SYSTEM LEGISLATION.

Commissioner Martinez made a motion to approve Resolution 2023-11 supporting artificial drainage system legislation. The motion was seconded by Mayor Pro-Tem Guevara and passed unanimously.

10. PRESENTATION OF FINANCIAL REPORT.

Mr. Rios addressed the commission regarding revenues and expenses for the fiscal year to date as compared to previous years. There was no action taken on this item.

11. PRESENTATION REGARDING PLANNING DEPARTMENT.

Mr. Ortiz addressed the commission regrading new development in the City including more than 100 homes currently under construction. He also stated that Pizza Hut, Pueblo Tires, Dollar General and Texas Smoke BBQ would begin construction in La Feria soon. There was no action taken on this item.

12. ADJOURN.

There being no further business to discuss, Commissioner Martinez made a motion to adjourn the meeting. The motion was seconded by Commissioner Zuniga and passed unanimously.
