3. DETERMINE QUORUM PRESENT AND CALL MEETING TO ORDER - MAYOR

4. PUBLIC COMMENTS

Stephanie Bauer addressed the Commission to request several upgrades and improvements to the parks and recreation activities offered.

5. CONSENT AGENDA:

- a. APPROVAL OF MINUTES FOR CITY COMMISSION MEETING HELD JUNE 28, 2022.
- b. APPROVAL OF QUARTERLY INVESTMENT REPORT.

Commissioner Lozano made a motion to approve the items under consent agenda as presented. The motion was seconded by Commissioner Martinez and passed unanimously.

6. <u>CONSIDERATION AND POSSIBLE ACTION TO DESIGNATE AN OFFICER OR EMPLOYEE OF THE CITY TO CALCULATE THE NO-NEW-REVENUE AND THE VOTER-APPROVAL TAX RATES.</u>

Commissioner Lozano made a motion to appoint Finance Director Frank Rios to calculate the no-new-revenue and the voter-approval tax rates. The motion was seconded by Commissioner Garcia and passed unanimously.

7. PRESENTATION AND DISCUSSION REGARDING THE FUNCTION AND OPERATIONS OF THE "BE A CHAMPION, INC. GRAB & GO" PROGRAM FOR FREE KIDS' MEALS, BY BETH CARTER.

Beth Cater addressed the Commission regarding the Be A Champion program. She explained the process

for children and families to get the free meals and the role of her staff. She also discussed other programs administered by the organization. There was no action taken on this item.

8. CONSIDERATION AND POSSIBLE ACTION TO APPROVE FINAL PLAT FOR PARKER HEIGHTS SUBDIVISION.

Commissioner Lozano made a motion to table this item. The motion was seconded by Commissioner Martinez and passed unanimously.

9. CONSIDERATION AND POSSIBLE ACTION ON ORDINANCE NO.2022-07 APPROVING A NEGOTIATED RESOLUTION BETWEEN THE CITY OF LA FERIA AND TEXAS GAS SERVICE REGARDING THE APRIL 28, 2022 COST OF SERVICE ADJUSTMENT FILING. Commissioner Lozano made a motion to approve Ordinance 2022-07 approving a negotiated resolution between the City of La Feria and Texas Gas Service regarding the April 28, 2022 Cost of Service Adjustment filing. The motion was seconded by Commissioner Garcia and passed unanimously.

10. <u>CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2022-17 TO ADOPT AND ALLOCATE FUNDS FOR AN OUTDOOR FITNESS COURT AS PART OF THE 2022 NATIONAL FITNESS CAMPAIGN.</u>

Commissioner Lozano made a motion to approve Resolution 2022-17 to adopt and allocate funds for an outdoor Fitness Court as part of the 2022 National Fitness Campaign. The motion was seconded by Commissioner Martinez and passed unanimously.

11. CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2022-18 AUTHORIZING SUBMISSION OF THE COMMUNITY DEVELOPMENT BLOCK GRANT-DISASTER RECOVERY (CDBG-DR) 2018 SOUTH TEXAS FLOODS RECOVERY FUNDING ADMINISTERED THROUGH THE TEXAS GENERAL LAND OFFICE FOR THE CITY OF LAFERIA.

Commissioner Martinez made a motion to approve Resolution 2022-18 authorizing submission of the Community Development Block Grant – Disaster recovery (CDBG-DR) 2018 south Texas floods recovery funding administered through the Texas general land office for the City of La Feria. The motion was seconded by Commissioner Garcia and passed unanimously.

12. CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2022-19 AUTHORIZING SUBMISSION OF THE COMMUNITY DEVELOPMENT BLOCK GRANT-DISASTER RECOVERY (CDBG-DR) 2019 SOUTH TEXAS FLOODS RECOVERY FUNDING ADMINISTERED THROUGH THE TEXAS GENERAL LAND OFFICE FOR THE CITY OF LA FERIA.

Commissioner Martinez made a motion to approve Resolution 2022-19 authorizing submission of the community development block grant-disaster recovery (CDBG-DR) 2019 south Texas floods recovery funding administered through the Texas general land office for the city of La Feria. The motion was seconded by Commissioner Lozano and passed unanimously.

13. <u>CONSIDERATION AND POSSIBLE ACTION ON CITIZEN PARTICIPATION PLAN FOR THE CITY OF LA FERIA.</u>

Commissioner Lozano made a motion to approve a citizen action plan for the City of La Feria. The motion was seconded by Commissioner Martinez and passed unanimously.

14. CONSIDERATION AND POSSIBLE ACTION ON AN INTERLOCAL AGREEMENT WITH CAMERON COUNTY FOR VARIOUS IMPROVEMENTS AT SCOTT SLOAN PARK AND THE VETERANS' MEMORIAL SPORTS COMPLEX.

Commissioner Lozano made a motion to approve the interlocal agreement with Cameron County for various improvements at Scott Sloan Park and Veterans' Memorial Sports Complex. The motion was seconded by Commissioner Martinez and passed unanimously.
