6. <u>CONSIDERATION AND POSSIBLE ACTION ON SALE OF UP TO 2,000 ACRE FEET OF WATER RIGHTS TO HIDALGO COUNTY IRRIGATION DISTRICT #6</u>

Commissioner Lozano made a motion to table this item. The motion was seconded by Commissioner Garcia and passed unanimously.

7. CONSIDERATION AND POSSIBLE ACTION ON SALE OF 250 ACRE FEET OF WATER RIGHTS TO LA FERIA IRRIGATION DISTRICT #3.

Mayor Pro-Tem Guevara made a motion to table this item. The motion was seconded by Commissioner Lozano and passed unanimously.

8. CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2023-19 AUTHORIZING THE LA FERIA INDUSTRIAL DEVELOPMENT CORPORATION SALE OF 202 INDUSTRIAL WAY IN TANDEM WITH A PERFORMANCE AGREEMENT FOR CERTAIN ECONOMIC INCENTIVES TO SHAD GUTIERREZ D/B/A TEXAS STATE ALARMS.

Mr. Ortiz explained that the LFIDC approved an agreement to sell the property in connection with a performance agreement. The performance agreement requires that they buyer continue to operate their business in La Feria for a certain period of time. The agreement also requires that ten jobs be created over the term of the agreement. Commissioner Lozano made a motion to approve Resolution 2023-19aauthoirizing the La Feria Industrial Development Corporation sale of 202 Industrial Way in tandem with a performance agreement for certain economic incentives to Shad Gutierrez d/b/a Texas State Alarms.

PRESENTATION FROM FULCRUM ENGINEERING FOR PURPOSES OF PROVIDING AN OVERVIEW AND NEXT STEPS ON DRAINAGE PROJECT.

George Lazaro addressed the commission regarding the city's drainage issues and possible solutions. The first proposed project would include making a drainage ditch along Canal Street wider and deeper and enclosing some of the ditch in concrete to help water flow more quickly into the drainage system. The estimated cost of this project would be around two million dollars. Two other phases of projects are still being investigated. There was no action on this item.

10. PRESENTATION FROM INFRAMARK REGARDING OPERATION AND MAINTENANCE OF THE CITY'S WATER AND WASTEWATER FACILITIES.

George Quilantan addressed the commission regarding maintenance and improvements done in the month of June. There was no action taken on this item.
