At 6:30 P.M., Board President Mr. Jose Becerra led everyone present in reciting the Pledge of Allegiance to the Flag of the United States of America. He then declared that a quorum of the LFIDC Board was present and called the meeting to order.

3. PUBLIC COMMENTS

There were no comments from the public.

4. <u>CONSIDERATION AND POSSIBLE ACTION ON MINUTES FOR MEETING HELD</u> APRIL 6, 2023.

Mr. Loya made a motion to approve the minutes for the meeting held April 6, 2023. The motion was seconded by Mr. Martinez and passed unanimously.

5. <u>CONSIDERATION AND POSSIBLE ACTION TO APPROVE A CONTRACT WITH SILVA, OTTING & SILVA FOR A RETAIL DEVELOPMENT PROJECT.</u>

Mr. Ortiz explained that the proposed contract would be for four months at a rate of four thousand dollars per month. Mr. Martinez made a motion to approve a contract with Silva, Otting & Silva for a retail development project. The motion was seconded by Mr. Loya and passed unanimously.

6. CONSIDERATION AND APPROPRIATE ACTION ON A RESOLUTION AUTHORIZING THE SALE OF 2.57 ACRES OF LFIDC-OWNED REAL PROPERTY LOCATED ON INDUSTRIAL WAY (LOT 1 LA FERIA BUSINESS PARK) IN TANDEM WITH A

<u>PERFORMANCE AGREEMENT FOR ECONOMIC DEVELOPMENT INCENTIVES, WITH VICTOR GARZA/VMK MATERIALS, LLC.</u>

Mr. Victor Garza addressed the board regarding his proposal to purchase the property. The property has been appraised at \$352,000, however the offer to purchase is \$209,000. Mr. Loya made a motion to authorizing the sale of 2.57 acres of LFIDC-owned real property located on industrial way (lot 1 la feria business park) in tandem with a performance agreement for economic development incentives, with victor Garza/VMK materials, LLC. The performance agreement will require \$250,000 investment and creation of at least two jobs by December , 2024. The motion was seconded by Mr. Martinez and passed unanimously.
