## **RESOLUTION 2024-28**

## A RESOLUTION OF THE CITY OF LA FERIA, TEXAS, REMOVING MEMBERS FROM AND APPOINTING MEMBERS TO THE LA FERIA PLANNING AND ZONING COMMISSION, AND ADDRESSING RELATED MATTERS

**WHEREAS**, Section 211.007 of the Texas Local Government Code requires the governing body of home-rule cities such as the City of La Feria to create a Zoning Commission, which may be combined with a City's Planning Commission, to create a Planning and Zoning Commission (PNZ); and

WHEREAS, the function of the PNZ is to recommend boundaries for the City's zoning districts along with appropriate zoning regulations for each district, and to provide reports and recommendations consistent with state law to the City Commission before the City Commission may act on a zoning regulation or change; and

**WHEREAS,** pursuant to such authority, the City of La Feria has established a PNZ as provided in Article VII ("Municipal Zoning") of the City of La Feria City Charter, and further provided in Chapter 14, article 14.02 of the City of La Feria Code of Ordinances; and

**WHEREAS,** PNZ Board Members are appointed by the City Commission for no more than three three-year terms, and may be replaced by the City Commission upon Board Member resignation, with or without cause, or at the expiration of a Board Member's term; and

**WHEREAS**, the City Commission has determined that it is in the best interest of the City to accept the resignation of certain members, appoint new members to fill vacant Board positions or expired terms, and otherwise appoint members who are willing to serve on the Board and attend meetings as necessary to effectuate the aims and purposes of the PNZ;
