### 4. <u>PUBLIC COMMENTS</u>

There were no comments during this item.

#### 5. Consent Agenda:

### a. Approval of minutes for City Commission Meeting held August 13, 2024.

Mayor Pro-Tem Guevara made a motion to approve the items under consent agenda as presented. The motion was seconded by Commissioner Martinez and passed unanimously.

### 6. Approval of appointment of an LFEDC Executive Director.

Commissioner Martinez made a motion to approve the appointment of Frank Rios as LFEDC Executive Director. The motion was seconded by Commissioner Garcia and passed unanimously.

### 7. Consideration and possible action on items related to the EPA Community Change Program:

- b. Authorize City Secretary to publish the request for statements of qualifications for architectural / engineering services for EPA Community Change Program

- d. Consider and adopt resolution to submit grant application to EPA for its Community Change Program
- e. Discuss the EPA Community Change survey form
- f. Consider and Approve Partnership Agreement with Non-Profit Organizations
- g. Consider and Approve Solidarity Partnership Agreement

George Lazaro addressed the Commission regarding funding available for infrastructure projects. The City is eligible to apply for up to twenty million dollars of grant funding for projects that use "green technology" to mitigate the effects of climate change. The city would not be responsible for contributing any matching funds. Mayor Pro-Tem Guevara made a motion to approve items 7a to 7f and take no action on item 7g. The motion was seconded by Commissioner Garcia and passed unanimously.

### 8. <u>Consideration and possible action on a contract with South Texas Emergency Care Foundation for ambulance transport services.</u>

Mr. Rios explained that the contract would be in place for five years. Commissioner Martinez made a motion to approve the contract with South Texas Emergency Care Foundation for ambulance transport services. The motion was seconded by Mayor Pro-Tem Guevara and passed unanimously.
