4. PUBLIC COMMENTS.

There were no comments during this item.

5. CONSENT AGENDA:

A. APPROVAL OF MINUTES FOR THE CITY COMMISSION MEETING HELD JULY 29, 2025.

Commissioner Lozano made a motion to postpone this item. The motion was seconded by Commissioner Martinez and passed unanimously.

6. PROCLAMATION COMMEMORATING THE 10TH ANNIVERSARY OF UTRGV.

Mr. Rios read the proclamation. There was no action taken on this item.

7. CONSIDERATION AND POSSIBLE ACTION ON RESOLUTION 2025-05 APPROVING HOLIDAYS FOR FISCAL YEAR 2025-2026.

Commissioner Martinez made a motion to approve Resolution 2025-05 approving holidays for fiscal year 2025-2026. The motion was seconded by Commissioner Garcia and passed unanimously.

8. CONSIDERATION AND POSSIBLE ACTION TO APPROVE PROPOSED TAX RATE CALCULATION FOR TAX YEAR 2025 (FISCAL YEAR 2025-2026) AND SET DATES FOR PUBLIC HEARINGS ON THE CITY FY 2025-26 BUDGET AND TAX RATE.

The proposed tax rate is 0.74 per \$1,000 valuation. The public hearings on the tax rate and budget will be held on September 16th and 23rd. Commissioner Lozano made a motion to approve the proposed tax rate

calculation for tax year 2025 (FY 2025-2026) and set dates for public hearings on the 2025-26 budget and tax rate. Commissioner Martinez seconded the motion, and it passed unanimously.

9. **DISCUSSION AND POSSIBLE ACTION ON AN AGREEMENT WITH CAMERON COUNTY ELECTIONS DEPARTMENT FOR ELECTION SERVICES RELATED TO THE NOVEMBER 4, 2025, SPECIAL CHARTER AMENDMENT ELECTION.**

Commissioner Lozano read a written statement, which will be attached to these minutes. Commissioner Martinez made a motion to approve the agreement with Cameron County Elections Department for election services related to the November 4, 2025 special charter amendment election. The motion was seconded by commissioner Garcia. Commissioners Martinez and Garcia voted in favor of the motion and Commissioner Lozano voted against it. The motion passed.
