

RESOLUTION 2026-14

**A RESOLUTION OF THE CITY OF LA FERIA, TEXAS,
REMOVING A MEMBER FROM AND APPOINTING A NEW
MEMBER TO THE LA FERIA ECONOMIC DEVELOPMENT
CORPORATION BOARD**

WHEREAS, the La Feria Economic Development Corporation ("LFEDC") is a Type B Economic Development Corporation established by the City of La Feria and primarily governed by Tex. Local Gov't Code 501 and 505, as may be amended; and

WHEREAS, the Articles of Incorporation of the LFEDC provide that the Board of Directors be comprised of seven (7) members; and

WHEREAS, the terms of the members of this corporation as established is for two (2) years; and

WHEREAS, the Articles of Incorporation of the LFEDC also provide that four (4) of the members of the Board of Directors must also be members of the City Commission; and

WHEREAS, the Articles of Incorporation of the LFEDC also provide that three (3) of the members of the Board of Directors must not be employees or officers of the City, or members of the Commissioners; and

WHEREAS, in accordance with state law and the Bylaws of the of the LFEDC, vacancies on the LFEDC Board shall be filled through appointment by a majority (at least three members) of the City of La Feria City Commission; and

WHEREAS, the City Commission has determined that it is in the best interest of the City to accept the resignation of a certain member and appoint a new member to fill the vacant Board position who is willing to serve on the Board and attend meetings as necessary to effectuate the aims and purposes of the LFEDC;

NOW, THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LA FERIA, TEXAS:

1. That the following current makeup of the LFEDC shall be adjusted by this resolution:
